

# MESSAGE OF THE ACTING GRAND MASTER

To The Most Worshipful Grand Lodge of Free & Accepted Masons of Alaska:

Welcome to the Second Annual Communication of this Grand Lodge, here in the Golden North, Land of the Midnight Sun, Interior City of Fairbanks. I do hope the weather meets with your approval for this time of year. The Arrangements Committee, chaired by Very Worshipful Brother Ralph Kavorkian, has worked long and hard to make your visit with us an enjoyable experience.

I address you today as the Deputy Grand Master, the Office I was installed into last February 5 in Anchorage. Most Worshipful Brother Roy Foss, Past Grand Master and the Installing Officer, was very pronounced with the instructions - "for you are aware that, in case of his incapacity to act in contingencies mentioned in our Constitution, you succeed to his duties and prerogatives further treasure up, therefore, the suggestions made to the Most Worshipful Grand Master, for you know not how soon they may have a personal application to you." Those messages have been deeply imprinted upon my heart and mind at all times since I received them.

Our Grand Master, Most Worshipful Brother Buckley Cecil Hazen, laid down his Working Tools of a very busy life on June 24, 1982, while in Bellevue, in the State of Washington, and his spirit is with us today.

It is my declaration that this Second Annual Communication of the Most Worshipful Grand Lodge of Free and Accepted Masons of Alaska be dedicated to our Friend, Brother, and Grand Master, Buckley Cecil Hazen. Immediately upon the completion of this Report, our Worshipful Brother Grand Chaplain, the Reverend John Edgar, will offer a Memorial Prayer for Most Worshipful Brother 'Buck' and the other forty-seven dedicated Brethren that have traveled to that Heavenly Workshop.

We miss them all greatly, but we know that they are enjoying Immortal Life in that Higher Brotherhood. Each, in his own way, made a valuable contribution while on this Earth and our lives were enriched by having them as Brothers in our midst - albeit for such a short time. But they have left their mark. While the work is not yet completed, they are no longer here to help. To continue the work at once becomes our obligation and our privilege, and provides us with a challenging opportunity to contribute in the knowledge that we, too, someday will be called to that Celestial Lodge above, but also with the hope that we will leave this world a little better 'for our having been here' and been given the opportunity to 'work as Masons'.

#### **Visits to Constituent Lodges**

Visits to all Lodges in this Grand Jurisdiction were made by your Grand Lodge Officers and, although the traveling Brethren were not as large in number as hoped for, the lessons learned and experiences gained will be most helpful for your Grand Officers' next visits.

Your Grand Secretary and 1 were prepared to assist you at all visits. All meetings were beneficial and many courtesies were extended and appreciated. At all meetings I encouraged the Lodge Officers to offer more educational material to the Brethren at their Lodge meetings to alleviate the doldrums of the routine regular business. Especially, I recommended to put the *Short Talk Bulletins* to work. These are now being sent to all Lodges in this Grand Jurisdiction by the Masonic Service Association of the United States, which organization we by vote of the membership at our First Annual Communication, elected to join and now much educational material is ours for the asking.

#### **Fraternal Recognitions**

All the other forty-nine Grand Jurisdictions in the U.S. and all nine in the Provinces of Canada along with thirty-six others around the world have accepted the Grand Lodge of Alaska into their ranks.

What a warm feeling of Brotherly Love there is when we meet our Brethren at the various meetings we have attended and the pride they feel for us, within their respective Grand Jurisdictions, over the fraternal recognitions which the new Grand Lodge of Alaska has received.

#### **Appointment and Acceptance of Grand Representatives**

As of this writing most of the Grand Representatives of and to Sister Grand Jurisdictions, with which we enjoy fraternal relations, have been appointed and/or confirmed; although a few are still pending. But, there are still a few others available for your consideration still awaiting your requests. Much pride has been in evidence as the Brethren receive their Commissions of Appointment an honor that was rarely offered to Alaskan Masons before we formed our own Grand Lodge.

A listing of all Jurisdictions with which we enjoy fraternal relations and the current status with respect to the exchange of Grand Representatives may be found in the Appendix to these Proceedings.

#### **General Information**

Your Grand Secretary, Right Worshipful Brother Gunnar Flygenring, has, through his diligence and efficiency, achieved the Grand Lodge Office to where it is firmly established and functioning as he promised to do when first elected to that Office. A job well done Brother Gunnar. Those who will follow in years to come will appreciate your untiring efforts.

Most Worshipful Brother Buckley C. Hazen requested that we attend the Conference of Grand Masters in Washington, D.C., February 13-18, 1982. Right Worshipful Brother Flygenring and I spent many hours in discussions with the Brethren

and we attended many meetings and workshops during the Conference which have helped answer many of the questions posed by the Brethren in this Jurisdiction.

The next Conference of Grand Masters will be in Dallas during the period of February 19-23, I983. Reservations have already been made for all your Grand Lodge officers to attend.

Most Worshipful Brother George R. Bordewick, Grand Master of Washington, was very instrumental in getting the I984 Conference scheduled for the city of Seattle. Historically, the Conference has been held on the East Coast since its beginning except for one year in Colorado Springs and the one two years ago in Orlando, Florida. It was, however, decided at the last Conference that five Regions be established across North America in order to allow different Cities, States, and Grand Jurisdictions to have the opportunity to host this important annual event. There were, of course, pros and cons on the subject, but that was the decision reached by the attending Grand Masters.

#### **Finances**

The financial status of our Grand Lodge has improved considerably by your passing Resolution No. 1-82 providing for a fee to the Grand Lodge General Fund from Petitioners for the Degrees and the very generous contribution of \$ 10.000 from the Alaska Masonic Research Association (AMRA) achieved as the result of a highly successful Gold Nugget Raffle.

#### **Special Installations**

On September 1, 1982, at Valdez, I installed Worshipful Brother Daniel J. Lawn (4) as Grand Standard Bearer.

On September 2, 1982, at Cordova, I installed Worshipful Brother Robert E. Cunningham (5) as Grand Bible Bearer.

On September 23, 1982, at Anchorage, I installed Worshipful Brother Neil R. Bassett (10, 11) as Grand Historian.

On November 15, 1982, at Kodiak, I installed Worshipful Brother Lewis E. Garrett (9) as Grand Sword Bearer.

## **Proclamation - Public Schools**

On April 1, 1982, I proclaimed the week of April 12 to 17, 1982, to be Masonic Public Schools Week. In the Proclamation I urged the Symbolic Lodges to carry out a program of encouragement toward excellence in education.

#### **Permission Granted for Temporary Change of Meeting Place**

On August 14, 1982, I granted permission to Kenai Lodge No. 11 to meet in Special Communication at Moose River in Sterling, Alaska, for the purpose of conferring the Master Mason Degree in an open air ceremony.

#### **Lodge Bylaws**

Four Lodges submitted five (5) bylaw changes to me for approval during the year. These were Anvil Lodge No. 2, Mt. McKinley Lodge No. 5, Glacier Lodge No. 10 (2), and Kenai Lodge No. 11.

I approved the bylaws change of Mt. McKinley Lodge No. 5 without referring it to Committee because it merely proposed an increase in membership dues to the necessary level to insure the continued operation of the Lodge.

The other proposed changes to bylaws were referred to the Committee on Bylaws and their subsequent approval based on committee recommendations.

#### **Irregularity Healed**

During the month of September 1982, Mt. Susitna Lodge No. 8 violated Section 141 of the Alaska Masonic Code, Prerequisite to Initiation: Conditions and Proceedings Under, by knowingly receiving a petition for the Degrees from a Petitioner who was less than twenty-one (21) years of age.

However, in that the Petitioner was not elected to receive the degrees until approximately ten (10) weeks after having reached his twenty-first birthday, I found that no serious (or real) damage had been caused to either the Lodge or to the Grand Lodge.

I healed the error and admonished that greater care be exercised in the future and to insure that the officers of the Lodge study and become conversant with the contents of the Alaska Masonic Code.

To The Most Worshipful Grand Lodge of Free and Accepted Masons of Alaska:

An analysis of the report will indicate that we, overall, managed to stay abreast of the dimits and deaths experienced by our Lodges but, also, that we do suffer greatly as a result of the dropped due to NPD category. This, then, appears to be one area where our Lodges may be able to reduce the loss in membership by staying in touch with the members and keeping them informed of the goings-on in the Alaska Jurisdiction. Such a course of action, coupled with greater diligence and perseverance in seeing the degree work of our many Candidates through to completion, including the required proficiency in the Third Degree, I am confident will turn the tide so that in the future we will register annual growth, rather than decline, in membership. A little effort on the part of many rather than considerable effort on the part of but a few certainly makes the burden feel much lighter and easier to carry and is the Masonic way. Try it - it really does work.

During the past year I was again fortunate in being able to attend the Annual Conference of Grand Masters (and Grand Secretaries) as well as several Grand Jurisdictions during their Annual Grand Communications. The experience gained, the friendships made, and the working relationships established have been invaluable and the benefits will be with us for many years to come.

I also traveled with the Official Grand Lodge party on all visits to our Symbolic Lodges during this Masonic Year and again enjoyed doing so and consider the traveling and visiting most valuable and rewarding experiences.

As you all know, we were saddened in June by the loss of our Grand Master, Most Worshipful Buckley C. Hazen. While his time with us in this Jurisdiction was of rather short, far too short duration, his name will remain forever among the records, in the archives of the Grand Lodge and the memory of him in the hearts of his many friends, among whom I am proud to consider myself. His work was not done but the Grand Lodge will live on the work must and will continue. It has been ably carried on by RW John C. Ingram, Deputy Grand Master, with whom, as the Acting Grand Master of Masons of Alaska, I have been pleased and privileged to work for most of this year.

It has, indeed, been a very distinct honor and a great privilege to serve as the first Grand Secretary of this Most Worshipful Grand Lodge. It is an honor I will always treasure. I hope I earned my wages and contributed in some small measure to the glorious future of this Grand Lodge and I thank you so very much for giving me the opportunity to serve.

NOW, THEREFORE, BE IT RESOLVED, that the above-quoted portion of Article 10 C of the A.M.C. be amended to read as follows:

... Past Masters of any other Grand Jurisdiction which is in fraternal communication with the Most Worshipful Grand Lodge of Alaska and which extends like recognition to Past Masters of this Most Worshipful Grand Lodge, while members of Constituent Lodges of this Most Worshipful Grand Lodge; ...

#### **RESOLUTION:**

**WHEREAS**, the Alaska Masonic Code does not clearly state eligibility for election or appointment to Grand Lodge office, and

**WHEREAS**, it has been the custom to elect and or appoint to Grand Lodge office those Brothers who are Past Masters and Members of the Grand Lodge, except in the position of Grand Chaplain, Grand Organist, or Grand Tyler, and

**WHEREAS**, Freemasonry has traditionally clearly stated eligibility for Grand Lodge Officers in the Masonic Code.

**NOW, THEREFORE, BE IT RESOLVED**, that Section 6 of the Alaska Masonic Code - Elections and Appointments - be amended by adding a new paragraph to read as follows:

**ELIGIBILITY**. No person shall be eligible to office in the Grand Lodge (except for Grand Chaplain, Grand Organist, or Grand Tyler) who has not been elected and installed Master of a Lodge of Masons and who is not a Member of a Lodge of this Grand Jurisdiction.

**NOW, THEREFORE, BE I T RESOLVED**, that the second paragraph of Section 6 of the bylaws titled "Elections and Appointments" be deleted in its entirety so as to maintain our long established and practiced customs of elections.

**WHEREAS**, such information can be displayed publicly without violating the prohibition of the use of the Masonic name or emblem as set forth in Section 40 of the Alaska Masonic Code;

**NOW, THEREFORE, BE IT RESOLVED**, that a new section be added to the Alaska Masonic Code to read as follows:

Section 40.5 Signs and Notices. A Lodge may place or erect a welcoming sign, subject to the Grand Master's approval, at each entrance to its community and may place a notice in an appropriate section of one or more local newspapers. Such sign and such notice may include no more than the Masonic emblem, the Lodge name, the location of its meeting place, the time(s) of its meetings, and the Lodge Secretary's telephone number.

At such future time as the funds of the Grand Lodge permit, we encourage a centralized approach to extend Masonic education within this jurisdiction.

## **Masonic Public Relations**

To The Most Worshipful Grand Lodge of Free and Accepted Masons of Alaska:

RW Deputy Grand Master, we, the members of the Public Relations committee respectfully report that our efforts to bring Grand Lodge news and Masonry in general to the public in Alaska have met with frustration and indifference.

Following the last Annual Communication, an effort was made in Anchorage to have small Masonic emblems placed on the doors of the Masonic members in the Pioneers Home, that those members might be identified. The officer-in-charge who asked to remain anonymous suggested some members may not wish others to know of their affiliation, but that it might be okay if all other Fraternal Organizations would do the

same. On contact, two of the other organizations said that they would look into it; no reply has been received to date.

On the passing of our Grand Master on June 24, 1982, a situation which we felt should be duly noted in print to the public, no information was made available to the public relations committee until just prior to the funeral and that information coming from an Obituary in the Anchorage newspapers.

In July, the Chairman of the committee contacted the editor of the Alaska Milepost, inquiring as to the possibility of having a small Square and Compass emblem placed near the information section of cities along the highway which have a Masonic Lodge to let Masonic visitors know that they were in friendly territory. The editor felt that all other organizations should be recognized, and there would likely be a fee. Further checking revealed that any such action would require a Grand Lodge resolution to change the existing Alaska Masonic Code. MW Brother James A. Williams has submitted a resolution which would most likely clear the way for such advertisement.

On December 15, 1983, a news release concerning the Grand Lodge Communication in February was sent to 24 daily and weekly Alaskan publications, as well as the Washington Masonic Tribune. To date, it is reported that several of those publications informed the public, much to our delight. Only the Anchorage papers, which were personally contacted, have failed to respond. We made the front page of the Washington Masonic Tribune.

It seems that the news media generally feels that unless the general public can participate in its entirety, discrimination prevails and they want to be no part of it.

Copies of the Sunday Supplement on Masonry which appeared in California newspapers have met with a questionable response with Brothers in Alaska. Approximately 50 percent seem to feel that it is not appropriate for us to spend the time, effort, or money to inform the public in this manner. However, we are informed by Grand Lodge members in California that they have received an influx of petitions for the degrees, nothing overwhelming, but it has met with a degree of success. We were informed by the Grand Lodge of Washington that it will soon produce such a supplement and we might use it if we so desire.

#### RECOMMENDATIONS:

Many have suggested a newsletter, quarterly or semi-annually, on Grand Lodge activities. This would seem appropriate provided the cost could be held to no more than \$1,000 per year and could be handled in conjunction with the Grand Secretary's office. Most of the Brethren feel that the Grand Lodge activities are conducted behind closed doors and that they are left out. Simply stated, they want to know what is going on, and where they stand.

A public relations member should be appointed within each Lodge, that he can personally contact the news media of items of interest where the general public can be included.

RW Deputy Grand Master, the members of the Public Relations Committee recommend that this report be accepted.

Kenai Lodge No. 11, in a very extensive program, awarded 13 different outstanding student-of-the-year awards for 13 different schools ranging from elementary to high school. We realize the task of setting up programs in your areas will be a great one and the challenges many. And, for the Lodges not having the financial capabilities for a large program, we asked that they might consider even the smallest of programs monetarily while promoting the highest degree possible of recognition and honor. We cannot afford the luxury of standing by while there is work to be done. We must join together in the preservation of this most important element and foundation of the American success story.

It has been and will continue to be the intent of this Committee to represent Masonry's demand for a basic education of a quality unsurpassed by any nation.

## **Bylaws**

To The Most Worshipful Grand Lodge of Free and Accepted Masons of Alaska:

We respectfully report that, with respect to the following changes, as requested by Lodges in this jurisdiction, we concur with the Grand Master's previous approvals:

1. Anvil Lodge No.

Article 3, Section 1:

From: The fees for the three degrees of Masonry shall be <u>One hundred seventy-nine dollars (\$179)</u>. and shall in every instance accompany the petition.

To: The fees for the three degrees of Masonry shall be <u>Two hundred fifty dollars</u> (\$250) and shall in every instance accompany the petition.

2. Glacier Lodge No. 10:

Article 3, Section 4:

From: The annual dues of each member shall be <u>Twenty dollars (\$20)</u>. payable in advance on the first day of January of each year.

To: The annual dues of each member shall be <u>Thirty-five dollars (\$35)</u>. Payable in advance on the first day of January each year.

Article III, Section 5:

From: A member may apply for and receive a life membership in this Lodge <u>after being a member in good standing for five (5) years</u> immediately preceding application by paying \$160 plus seventy-five percent (75%) of the accumulated yearly dues from the year of application to and including the year the member becomes sixty-one (61) years of age, or a minimum of \$160, whichever is greater. To: A member may apply for and receive a life membership in this Lodge immediately upon his request, provided he has been a Master Mason in good standing for five (5) years immediately preceding his application and pays the

sum of \$ 160.00 plus seventy-five percent (75%) of the accumulated yearly dues from the year of application to and including the year the member becomes sixty-one (61) years of age, or a minimum of \$160.00, whichever is greater.

### 3. Kenai Lodge No. 11

Article III, Section 1:

From: The fee for the three degrees shall be <u>Two hundred dollars (\$200</u>). and in addition any fees required by the Grand Lodge, which must accompany the petition.

To: The fee for the three degrees shall be <u>Two hundred twenty dollars (\$220)</u> and in addition any fees required by the Grand Lodge, which must accompany the petition.

#### 4. Mt. McKinley Lodge No. 5:

Article III. Section 1:

From: The annual dues for each member shall be <u>Twenty dollars (\$20)</u> payable in advance on the first day of January each year.

To: The annual dues for each member shall be <u>Fifty dollars (\$50)</u> payable in advance on the first day of January each year.

# **Report of Grand Lecturer**

To The Most Worshipful Grand Lodge of Free and Accepted Masons of Alaska:

It was his conviction that the neon signs that are used in some of our Lodges detract attention from the Three Great Lights.

Number 2 is Article 27, on page 10, referring to standard work which reads: Standard Work. The Esoteric Work, together with the Monitorial Work, as approved by the Grand Lodge at its First Communication, is the Standard Work of this Grand Jurisdiction. Constituent Lodges shall practice this Standard Word and no other.

Number 3, Section 29, on page 26, which speaks of ciphers, reads: The printed copies of the Standard Work Cipher authorized by this section, may be sold only to Secretaries of Constituent Lodges of this Grand Jurisdiction for distribution to members.

After our visit, he took these suggestions and changes to Fairbanks to be put in proper form for your consideration and information at this Communication, and I felt that it was my obligation to make you, the Grand Lodge, aware of this. In the last two years it has not been my intention to intimidate or aggravate Brothers, but to try to standardize our work whenever possible, in the most tender manner that it could have been done. # **Report of Grand Historian**

To The Most Worshipful Grand Lodge of Free and Accepted Masons of Alaska:

A number of projects came to mind or were suggested this year relative to Masonic History. However, when I began to look at our Grand Lodge history, I generally found that much pertinent information was very widely scattered, from the details described in our first Grand Historian's report to narratives in several Lodge Cable Tows or Trestleboards. Significant information is contained in Washington Grand Lodge proceedings and AMRA reports. There is redundancy in many of these sources but many have good bits of information. None of them had the total story. I have, therefore, tried to pull together as much information as I could find coupled with personal knowledge. This material has been placed in a loose leaf notebook with the thought that each succeeding Grand Historian could add historical information for his year. At some future date, a printed version could be issued under the unimaginative title of "The First Ten Years" or "The First Twenty Years."

I do not claim that this narrative history is complete. Hindsight is still a very wonderful thing and some ideas for improving the narrative came too late to implement. I tried to include as many names, with Lodge identification, as possible of Brothers responsible for the existence of our Grand Lodge. Some of these names were never recorded. I also found some differences among authors as to what happened on what day in February 1981. In these cases I made a judgment call as to which I felt to be most authoritative.

#### I therefore recommend that:

- 1. The document I prepared be reviewed by two or three knowledgeable Masons for accuracy and suggestions for additions. This assumes anybody wants to continue a history in this format.
- 2. Succeeding Grand Historians make serious efforts to personally interview the participants in our history to fill in the gaps as to the events which I may have omitted and, more especially, to record the identity of those who worked so hard on Grand Lodge formation but whose names were not recorded, generally because they weren't on committees or because only their committee work was recognized.

I learned last month that there is a Masonic headstone temporarily stored in the Grand Secretary's office needing research and identification. I would recommend that the next Grand Historian begin that research.

# **Grand Master Biographical Sketch – Buckley C. Hazen**

Our second Grand Master, MW Buckley C. Hazen, originally a Canadian, was born in Winnipeg, Manitoba on March 14, 1917, to Cecil Claude Hazen, a Master Mason, and Adelaide Palen Hazen. He had two sisters.

He spent his early years in Mayerthorpe, Alberta near the City of Edmonton and left Canada when he was 16 to live with maternal relatives in Spokane, Washington. He attended public schools in both Alberta and Spokane and began learning carpentry at the age of 16, to which he devoted his entire life.

MW Brother Hazen, known as "Buck" to his friends, came north to Alaska in 1942, and worked as a construction crew foreman in Skagway and at the former Ladd Field at Fairbanks, and was a partner in Batchelder & Hazen Construction in Kodiak. Later, he was Carpenter Shop Foreman for what eventually became the Alaska Department of Highways and retired from that position in October 1980. After retirement he started Sword Construction Co. He also collected swords as a hobby.

On March 14, 1949, MW Brother Hazen was united in marriage to Barbara Louise Hackenberger. She, as well as her mother, was active in the Order of the Amaranth. Barbara and Buck had two sons, Lee and Craig, and a daughter, Claudia. Barbara passed away in December 1963, leaving MW Hazen to raise their children as a single parent. This he did in an exemplary manner, raising all three to be respected, hardworking citizens.

He was very active in several civic and other organizations including the Grange, Salvation Army Board of Directors, Shrine hospitals, Fairbanks Curling Club, and the Episcopal Church.

His own Masonic affiliations began when he was elected to receive the Degrees of Masonry in Tanana Lodge No. 162 (now No. 3) on August 9, 1944. He became a Life Member of the Lodge in September 1968. He occupied several stations and places in the Lodge and served as its Worshipful Master in 1975.

MW Brother Buck was a hard worker for and a strong believer in the aims of the Alaska Masonic Research Association, the organization created to work toward the formation of a Grand Lodge of Alaska. When this goal came to pass, his Brothers honored him by electing him Deputy Grand Master in February 1981. He was installed as our second Grand Master on February 5, 1982.

The Grand Lodge was his first love but he also sought higher education in Freemasonry. Brother Buck was a philosopher of the first order and a true Mason in life as well as in Lodge. He was a Life Member of Nile Temple, A.A.O.N.M.S., in Seattle

and became as Associate Member of Al Aska Temple in 1974. He served the latter Temple as Ambassador at Large. He was also a 33rd Degree Mason of Scottish Rite.

MW Buckley Hazen laid down his Working Tools on June 24, 1982, in Bellevue, Washington.

# Acting Master Biographical Sketch – John C. Ingram

RW Brother John C. Ingram is a native of Indianapolis, Indiana, having been born there on March 14, 1929, to William and Grace Ingram. He received his schooling in Indianapolis, graduating from Arsenal Technical in 1946.

Intent on homesteading in Alaska, RW Brother John came north in the spring of 1949, returning to Indianapolis a year later to elope with his high school sweetheart, Dorothy Jean Branam, known to their friends as Dottie. They were blessed with a daughter, Candace, and two boys, John Jr., and Thomas.

RW Brother John served four years in the Marine Corps and began homesteading at Cooper Landing upon his discharge in 1954. Seasonal construction work as a heavy equipment mechanic/operator allowed time for family life and improving the homestead. In 1966 the family moved to Soldotna to be near the high school, and began a business with a garage and service station. When the business was destroyed by fire in 1981, John and Dottie moved back to Cooper Landing.

He was enrolled a Master Mason in Seward Lodge No. 219 (now No. 6) on May 2, 1961, and he became its Worshipful Master in 1965. Under the Grand Lodge of Washington, he served as Deputy of the Grand Master for District No. 2 (1967-1969), Grand Sword Bearer (1969-1970), and on several committees, including Chairmanship of the Committee on Credentials for several years. When Kenai Lodge No. 307 (now No. 11) received its dispensation in 1971, he was elected its first Master (1971-1972), having served as such in 1970 and continuing on through 1972. He was elected Senior Grand Warden when the Grand Lodge of Alaska was formed in 1981. Upon passing of MW Buckley C. Hazen in June 1982, RW Brother John assumed the duties of Acting Grand Master.

He is a member of both the York and Scottish Rites and is currently the Orator of the Soldotna Lodge of Perfection. He is a 33rd Degree Mason; was awarded the DeMolay Legion of Honor, and served as Potentate of the Al Aska Shrine Temple in 1977. Other memberships include: Order of the Amaranth; Red Cross of Constantine, Alaska Conclave; and Royal Order of Jesters. RW Brother John is also the Grand Representative of the Grand Lodges of Indiana, Ohio, and Washington near the Grand Lodge of Alaska.

## MW H. Wendell Patch, Grand Master of Oregon

Right Worshipful Brother John, Acting Grand Master, Distinguished and Honored Guests of the Most Worshipful Grand Lodge of Alaska, Delegates and Brethren All:

Some of you have heard me say already since I have been here how pleased I am to be with you and share the hospitality extended by your Grand Lodge Officers and have the opportunity to visit my son, who is an attorney in Anchorage, and now owns property here and to again visit the site of my youth. Before World War II, when I graduated from flying school, my first duty station was Elmendorf Field, then a part of Fort Richardson. So each time when I come back here to visit or attend a wedding or hunt these beautiful mountains and valleys, there has always been a feeling of warmth. Sometimes I wonder why I didn't stay here, because I feel a kinship to the people of Alaska who are in fact, many times, as your Grand Lodge is, pioneers yet. I want to thank you, each and every one, through your Grand Master for this hospitality.

This morning the Mayor of the North Star Borough spoke to us. He had a good coach, I believe. He seemed to understand what we were all about because he mentioned our precepts and how we have at times dispensed charity, which is one of those precepts. Just a few moments ago our Grand Chaplain called our attention, in other words, as to how Masons live and exercise their lives in the furtherance of those precepts. The thought occurs to me, and it is not a new thought, that the menu in which we offer Freemasonry to our Brethren, to the World, and in which we use our own working tools, is far different now than when Masonry was in its zenith. What I refer to here is membership. The menu is far different than that which many of our Masonic Ancestors who founded this nation, for example, felt. To explain what I am talking about, in very simple words, to attempt to be brief, I find today that the effect of Fabian belief has so altered the manner in which we as citizens of this Great Republic dispense charity that the Masonic Lodges and the churches which were at one time the principal benefactors of the needy are no longer that principal benefactor. We now have the Lions, the Rotarians, and other organizations supporting much of the charitable endeavors that you and I as Masons, at one time supported.

Now, we as Masons belong to those organizations and are doing charitable things under other agents. Then, of course, we have the generous hand of big government which is providing for the needy in such an abundant manner. What this has done, as far as I see, is provide for a class of permanent needy. No longer does man consider need as a temporary condition, something to be overcome by industry, by application, or by a

change in the physical circumstances in which he lives and may have no control over. I use this not to try to sell you on political philosophy, but only to indicate that there has been a change in the ambience in which we live which affects one of our tenets or one of our principles or precepts, whichever label you apply to it. The reason I believe it is important for us to assess the change in the ambience of Freemasonry is so that we will know how to react. No, I would rather not use the word "react," some will know how to act positively in that changing atmosphere.

It seems to me, for example, that we have much to do to assure our viability. The precepts we don't argue with are those that were enunciated by our Mayor and by our Chaplain and which will further be enunciated later. It's only how we package those, how we export them, to profit Freemasonry that concerns me, and I urge then that each of us give sober and deep or concerted reflection to those things which affect how we operate as speculative Masons.

It seems to me; however, this is only a notion, that if you and I would concern ourselves with such concerns, as I have tried very briefly to describe, we will, in the end, strengthen our Craft and insure its availability, its viability for the future, and its availability for our sons, our grandsons, and those who follow after us 200 or 300 years from now and enjoy it as we have 300 years after it was given to us. I believe that this Fraternity means as much to me or you as it did to those early Masons who had the foresight to meet and establish ritual, custom, and precept, and I think this is the least we can do to assure its future.

Down in Oregon they sometimes say, "Wendell, you tell us that you are thinking so much that at times we don't have time to really experience the thing that we came here to experience." Brethren, I thought really I was doing that. I wouldn't read this poem I am going to read because I believe the one overriding concern that's going to enable us to insure viability in the future is the love inherent in Freemasonry under the Fatherhood of God or call it another thing: Brotherhood. It is that which binds us universally and that really is the purpose of what I tried to enunciate a little bit ago.

Rudyard Kipling experienced that when he wrote this poem titled "The Mother Lodge" and many of you, I am sure, have heard it and read it. But I like it and I would like to close on this note because Kipling tells us in this poem how diverse was the membership of his Mother Lodge, for it embraced men of all different faiths and of all different callings. It embraced them in a warm atmosphere. It embraced Brethren of different coloring and; therefore, perhaps different ways of life and it tells us a great deal about the man himself. And the poem goes like this:

THE MOTHER-LODGE

There was Rundle, Station Master, An' Beazeley of the Rail, An' Ackman, Commissariat, An' Donkin' o' the Jail; An' Blake, Conductor-Sargent, Our Master twice was 'e. With 'im that kept the Europe shop. Old Framjee Eduljee.

Outside-"Sargent! Sir! Salute! Salaam!"
Inside-"Brother," an' it doesn't do no 'arm.
We met upon the Level an' we parted on the Square,
An' I was Junior Deacon in my Mother Lodge out there!

We'd Bola Nath, Accountant,
An' Saul the Aden Jew,
An' Din Mohammed, draughtsman
Of the Survey Office too;
There was Babu Chuckerbutty,
An' Amir Singh the Sikh,
An' Castro from the fittin'-sheds.
The Roman Catholick!

We 'adn't good regalia. An' our Lodge was old an' bare. But we knew the Ancient Landmarks, An' we kep' 'em to a hair; An' lookin' on it backwards It often strikes me thus. There ain't such things as infidels, Excep', perhaps, it's us. For monthly, after Labour, We'd all sit down and smoke, (We dursn't give no banquits, Lest a Brother's caste were broke), An' man on man got talkin' Religion an' the rest. An' every man compann' Of the God 'e knew the best.

So man on man got talkin'
An' not a Brother stirred
Till mornin' waked the parrots
An' that dam' brain-fever-bird;
We'd say 'twas 'ighly curious,
An' we'd all ride 'ome to bed.
With Mo'ammed, God, an' Shiva
Changin' pickets in our 'ead.

Full oft on Guy'ment service This rovin' foot 'ath pressed, An' bore fraternal greetin's To the Lodges east an' west, Accordin' as commanded From Kohat to Singapore, But I wish that I might see them In my Mother Lodge once more! I wish that I might see them, My Brethren black an' brown. With the trichies smellin' pleasant An' the hog-darn( I) passin' down; An' the old khansamah(2) snorin' On the bottle-khana(3) floor, Like a Master in good standing With my Mother Lodge once more!

Outside-"Sergeant! Sir! Salute! Salaam!"
Inside-"Brother," an' it doesn't do no 'arm.
We met upon the Level an' we parted on the Square,
An' I was Junior Deacon in my Mother-Lodge out there!

My Brethren, I would urge that we as Masons meet on the Level and part on the Square; that we, having good regalia or not, know the precepts of our Fraternity, know how to make them known to the uninitiated, but above all, that we exhibit in our lives that Brotherhood of which our esteemed poet predecessor spoke in this very eloquent poem. ## MW Ludvik H. Jun, Grand Master of Montana

Right Worshipful Brother Deputy Grand Master and Distinguished Brethren All:

It is indeed a pleasure to come to the Grand Lodge of Alaska. As your RW Deputy Grand Master and Acting Grand Master indicated, we have attended several sessions. One that he didn't mention was in Tucson, Arizona, where they were celebrating their centennial observance. On that occasion the Grand Master there asked RW Brother John Ingram to represent the Northwest. You know, 100 years ago in Arizona, they had some doubts about whether the Grand Lodge could succeed down there, some of the Lodges that were in existence there, that I believe belonged to the Grand Jurisdiction of California, did not care to join, but they did succeed to celebrate their 100th Anniversary. RW Brother John informed them that Alaska had just held their First Annual Communication and that they would eventually, in 99 years, celebrate their centennial and we all know that you will.

I was most happy to reminisce a little and renew some acquaintances here. I was in Alaska in 1976 and I visited Kodiak Lodge No. 295, I believe it was then or 245, No. 9 now. I was reminiscing with Brother Kirk, and he will convey my greetings to the Brothers down there. We had a very nice session in that Lodge. It was the first lime that I ever had to pass an examination to get into a Lodge. Usually someone is around to vouch for me, but I was a long way from home, five days to get up here by the Alcan Highway. I was sorry that we had ferry reservations and we had to leave for Homer the day that the then Grand Master, MW Brother Fred Sandoz, was making his official visitation that evening. We just missed each other by a little bit. I am also happy that the Brothers that have been in Montana are identifying themselves to me. A week from today I will be in Arden, Montana, and as a Brother here, I will tell them that I did talk to you, and I will convey your greetings to them down there in the Bighorn Country.

Upon my travels to the various jurisdictions, I have been making somewhat of a nuisance of myself by talking to some of the other visiting dignitaries - identifying some of the problems they have - but we all have problems. I don't call them problems, I call them challenges. But I am a retired educator in mathematics, specifically, and if you have a problem there is a solution, even though it is a partial solution. So if you have a problem there is a solution to it. One of them that I investigated a little bit is the Entered Apprentices. There is some comment on Entered Apprentices. It is the first time they are exposed to Masonry - first impressions are very important, I think. Now, in some of the jurisdictions, I am informed that it's as high as 30 percent of the Entered Apprentices that do not go on to take their Fellowcraft Degree. In Montana, there are many that do not and there is a reason for it, I guess, but I don't think our percentages are nearly that high. I tried to find out what the reason was. You know, in the Rocky Mountain Conference of the five Mountain States, we present papers and we discuss things. I have been honored to attend a Canadian conference of the four Western Provinces for the last four consecutive years. Why don't the Entered Apprentices go on to take their Fellowcraft Degree? I don't know whether you are going to agree with any of this or believe it - one of the many things mentioned was that they cannot memorize or do not want to memorize. They find out they have to do some memorizing and they do not go on. Can we do something about it? I am not for changes or against them, but if changes need to be made, sometimes they can. Some jurisdictions have made changes. I don't know what success they have had. Another one they object to is the penalty of the obligation. They think it is quite severe; they wonder what the next one will be but they never come back to find out. It is more severe as we know, and the third one and so on.

RW Brother John Ingram indicated that we visited the Grand Lodge of Kentucky in October. There were 31 jurisdictions present. I had the good fortune to converse with the Grand Master of Delaware. He sent me a Xerox copy of a page or two of their code, and they insert a word or two there about how symbolically the penalty will be severe throat cut from ear to ear and so on. Another one, well I don't know what you will think of this one. When we go out of the preparation room some of them think that it is demeaning to be deprived of some of their clothing, invading the privacy of their body, and they are wondering what is going to happen the Second and Third Degree. Some of these ideas might be farfetched, but we are getting down to the nitty-gritty here. They

don't come back to find out. Can we do something about that? Possibly, possibly not. Here is one that I just picked up recently with some of my recent visitations. I suppose it would be up to the investigating committee to do something about this, but I don't see how they could arrive at that. These people thought that the Masonic Institution was a very wonderful fraternity, and that there were only the most upright and moral people joining it. They were merely curious and wanted to know if they could be accepted into the fraternity, and so when they were, that was enough. They really gave a somewhat flippant answer, "Well, I just wanted to know whether I could get in or not," and that was the end of that. These are some of the reasons, there are many more, also.

Well, you have much business to attend to and again RW Sir, it is indeed a pleasure. You know it is a long way up here to Fairbanks, but it isn't any farther to come up here than it is to come down to Great Falls June 24 and 25, to our 117th Annual Communication for the Grand Lodge of Free and Accepted Masons of Montana. We look forward to seeing you and your good wife, Dottie, on that occasion. Thank you.

## MW George R. Bordewick, Grand Master of Washington

RW Deputy Grand Master, Distinguished Brethren, Masters, Wardens, and My Brethren:

I was in this hall during the administration of MW Brother Roy Foss. We came up here and put on a District Meeting. I was the Chairman of the Finance Committee of the Grand Lodge of Washington, and I would like it understood right now that I am not the guy who told you that you needed \$200,000 to get it going. However, we have had some interesting discussions ever since. There was a car alongside a cliff with a stunt driver in it. He dove out of the car into the surf 100 feet below. The lady turned to her guide and said, "How does he do it?." The guide said, "I don't know. They have a new one every time."

Up here you see the Standard of the Grand Lodge of Washington. We have a very efficient Standard Bearer this year. He has been delegating his duties. When the Grand Lodge is not in session, the Grand Master is the Grand Lodge, so he felt it his duty to follow me around as much as he could to bring the Standard in. Your Grand Master graciously gave us permission for it to stand there. Perhaps we could get the Grand Standard Bearer to do something about it. Perhaps this Grand Lodge should have a Standard. So 1 thought you would like to see what a Standard is and to hold it up before you and give you something to emulate.

We are going to publish a supplement in every newspaper that is published in the state of Washington and the state of Alaska on September 20. You have seen copies of it. We are indebted, as you know, to California for its format. I hope it does some good things for you. I knew of no way to separate our interest in the state of Alaska from yours, so after we kicked it around for a while. I said, "We'll distribute it throughout the length and breadth of Alaska, and let's hope we do our friends some good."

I was in a meeting a while hack in Longview, and I was introduced to a Fellowcraft who was a radio officer on a tanker ship. Because we were doing a Third Degree, he couldn't be with us, but he was there for dinner. I am a frustrated sailor. I made a couple of half-hearted attempts to gel on as deck boy on freighters in the old days. I took a wireless operator's job for awhile until other things came along that I was more interested in. That's why I enjoyed talking to this Brother. I asked him why he had become a Mason. He said, "Well, I am glad you asked me. You know ships are much more complicated than they used to be when you were interested in them. Twenty-five, thirty, forty thousand ton tankers are very critical. Traffic is crowded. The slightest error by the navigating officer can cause a catastrophe. I noticed the deck officer and the engineering officer were Masons. After long periods of duty, long periods of exasperation, when you would normally expect them to be irritable and have no time for anybody else, invariably they were gentlemen. People ashore in the office who were Masons seem to take a greater interest in their crew and personnel than other people did. So I thought I would become a Mason.

A while back, I was in a meeting sitting next to a young man, and he asked me what I did, and 1 told him. He was a truck driver in the construction industry - drives a dump truck. He said, "You know. I always wanted to be a Mason. The guys on the crew who were the good guys, the guys you could count on, the guys who would cover for you, put in an extra day when you needed a day off, they were always Masons. Nobody ever asked me." So I told him how to become a Mason. I joined the Grange a while back because I thought I might need some insurance that I might not be able to get the usual way. I went into a Grange Hall and I took the ceremonies. It was interesting to do because it is pretty evident where the ceremonies of the Grange come from. But I paid my dues. I went to this one meeting. I haven't had a bulletin from them since. My interest in it, I admit, is very casual. I wonder if it isn't true that people join our organization looking for something, and when they never hear from us, never get any communication, they end up with the same feeling about the Lodge as I have about the Grange.

I guess you could say that your Acting Grand Master and I are in the business of promoting enthusiasm. Enthusiasm is one of the hardest things in the world to find. If you have anything to do with managing men, you know that you can pick up lots of guys who will take a paycheck. The people who will make your cause theirs at heart, who will work for the success of the organization because they want to, are fewer and farther between. The Greeks had a word they called "enthayous." Strangely enough, it has come down to us almost unchanged for "enthusiasm." It means a Greek spirit of God within us. Some of us around here are wearing this old badge, and it is given to us in Washington the day we are elected Grand Master, the first of the four Hebrew characters which we use to designate and make the name of God. It implies enthusiasm, the spirit of God within us. If this organization of ours is to succeed and continue in the future, it will be necessary for each one of us to have enthusiasm, to feel the spirit of God within him, and to feel the necessity to reach out to his fellowman and devote all of his energy to promoting the good will of the good of this enterprise, this social fabric that we are all taking part in.

And so, RW Acting Grand Master, it is a privilege and a pleasure to come back after several years to this hall and sit in this Grand Lodge's Annual Communication and listen to your determination and to wonder where you will be ten years from now. It is my conviction that young people all over this land are looking for a more secure, and dedicated way of life. We have it now. All over the place I feel that there are people who are looking for what we have. If our supplement does us any good at all, as it seems to in California, I heard this idea a year ago, there will be people coming to you and saying what does that badge mean? What's that square and compass - how can I join it? It's like fishing for salmon, I guess. Poaching off Elliott Bay, if you jerk up too quick you take the bait and lose the catch entirely. So, we need enthusiasm, we need caution, and we need wisdom. I am sure you Brethren have it. Thank you very much.

## Byron C. Jenkins, Past Grand Master of Nebraska

Right Worshipful Deputy Grand Master, Distinguished Guests, Grand Lodge Officers, Brethren All:

Three years and I'll be back as long as the pocketbook and the health hold out. Before I say anything further, Grand Master, I do have a presentation. I brought a gavel. Brethren, when the Grand Lodge of Nebraska was formed in 1855, it was formed in Indian Territory. The residents of that area were Sioux, Arapahos, Chevenne, and Pawnees; all nice, friendly people. On the western bank of the Missouri River were three towns: Bellevue, Nebraska City, and Omaha. A trading post was established in 1810 in Bellevue, and it brought to the community a few Indian agents, a few trappers, fur traders, and a couple of Presbyterian missionaries. This was the total community of Bellevue. Among those men were fifteen Brothers who petitioned the Grand Lodge of Illinois to form a Lodge. It was granted. They met on the second floor of the trading post. Now, the trading post is long gone, but this gavel is made of the wood from that trading post in Nebraska. This is an historic gavel. I don't know how I came to wind up with two of them. My own Lodge has one in its archives They don't need one. I thought that maybe this souvenir of the history of Nebraska might mean something to you Brothers, and I am going to present it to RW Brother John and ask him to use it to rap once or twice in this session and put it in your historical mementos as an item from Nebraska.

The Acting Grand Master accepted the gavel as the property of the Grand Lodge of Alaska.

Now Brethren, I said there were three communities, Nebraska City and Omaha being the other two. They formed a Grand Lodge of Nebraska with a total membership of the three Lodges of 78 Brethren. Nebraska City lies 40 miles south of Omaha and at that time there were two ways of moving around the countryside. You walked or rode a riverboat. The convention to form the Grand Lodge was held in Omaha. There were no riverboats available for Brethren from Nebraska City. They walked those 40 miles over the prairie to get to Omaha to form the Grand Lodge. This is dedication. These were real Masons.

Now they reach down in their own communities to get their members. The Grand Lodge grew and grew rapidly. Most of our Grand Lodges now are having problems with losing members. There is only one way, Brethren, you can't seek in another man's backyard for your members. You have to do it in your own community. We have quite a program in Nebraska, guest nights, and they work tremendously well where the Lodges use them. We have those Lodges, as you no doubt in your jurisdictions have them, which say, "We didn't do that when I was Master of my Lodge, we are not going to do it now, that's not right." Brethren, the country has changed, and in some respects Masonry must change. We must reach out. We must let the community know what you are and what you proclaim. The only way to inform nonmembers is to speak to them about Masonry.

You know, back in the days of sailing ships there was a Captain sailing down the coast of Brazil. The wind died out, and he had been becalmed for several days. He was running out of fresh water and couldn't see land. After several days of this he saw a small boat coming along with two men paddling. He hailed them and said, "We are running out of fresh water." One of the men yelled back. "Put your buckets down where you are." The Captain thought he must not understand, so he hailed again, "We are out of fresh water." Came back the voice, "Put your bucket down where you are." The third time the Captain said, "We are out of fresh water," and the voice came back, "Put your bucket down where you are." So he finally got a bucket, tied a rope to it, and let it down. It came up with fresh water. He didn't know he was becalmed in the mouth of the mighty Amazon River that carries fresh water two hundred miles out to sea. Put your bucket down where you are. This we must do in Masonry. Put that bucket down and draw up the fresh water. Talk in your community. Draw in new Brothers. You will grow. I have all the confidence in the world that this Grand Lodge of Alaska will be one of the finest in the world. Thank you Brethren.

# MW Frank M. Hartung, Grand Master of Wyoming

Right Worshipful John, Distinguished Guests of the Grand Lodge of Alaska:

You can see how easily John is impressed. He was impressed by me at the meeting in Seattle. I feel kind of like Liz Taylor's fifth husband. You know what you are supposed to do, but after all these other speakers you don't know how you are going to make it interesting. We have heard about problems or opportunities or whatever you want to call them. I have had a million things going through my mind. They have got to go single track because I don't have that much mind. But in thinking about them and some of the things that we have been trying lo do the last few years in our Lodges and in our state of Wyoming - I was interested in one thing that was said to me because I thought it might be useful to me. That was a statement made from the Grand Lodge of England when they felt they must reply to all the questions about solicitation. They came out with this statement on proper solicitation. I read it and put it where you usually put a lot of your mail that comes. We have been doing this for about five years in Wyoming. It finally caught up with us I guess. My Lodge has tried it. Of course, you always like to think your Lodge is the best in the state. I am no different from anybody else. I think our Lodge is.

It's more progressive, and it has helped us. Several years ago you had to practically beg somebody to take the appointments in the line. We have people now asking, "Why wasn't I appointed this year'." That is a healthy situation.

We call them History Nights and you call them Laymen's Nights. Last year our Grand Master, Bill Ryder, had a professional public relations organization prepare packets for us to put out to the Lodges. They were wonderful packets. Sometimes it does not hurt to have somebody from the outside look at your organization. Some of our terminology we think nothing about, but when you are talking to somebody who is not a Mason sometimes you might offend them. For example, in our literature we talk about the profane. Boy, I went right to my dictionary. I didn't like that word. Nasty word to me it sounded like, and all you mean was he was uninitiated, a non-Mason. "Call him a non-Mason or uninitiated," he said. "When you talk about your building, I think you would be better off if you didn't call it a temple, because that gives you the connotation that it is religious, tied in with a sect or a religion. Call it a Masonic Building." We manifested a lot of ideas and terminology from him that would probably help us. In all of the visits I made as Deputy Grand Master and Senior Grand Warden, I told them, "This packet will help you if you really use it." But the local Lodges have to use it and put it into effect, and it can help improve attendance and membership and everything all the way around. Get people involved.

One of the opportunities that we are talking about is losing Entered Apprentices. Part of our solution to try to help this is that the total fee for all three degrees must accompany the petition. Before we have had a percentage payment. Sometimes after they take the First Degree, maybe because of the memory work, they do not come back. It is hard to pinpoint why they don't. We have picked up some, kind of put the heat on them and got them to finish. Then, in addition to that, in Wyoming we have been selling Masonry too cheap. For years and years we have had resolutions, they are always defeated. Our smaller Lodges, a lot of them, say we don't need anybody to tell us how to run our business, and you look at their financial conditions and they are broke. My Dad in 1915 paid \$50. That's all I paid in 1945 to join the Masons. Our minimum in our code says \$50, and we cannot get it raised through our resolutions in Grand Lodge. It is ridiculous. Our Lodge recently upped it to \$ 150, and that is the highest of any of them in the state. If you sell something cheap, people expect something cheap. You could probably put a Cadillac right out here on this parking lot and put a \$5,000 sales sign on it and nobody would take it. You up that to \$15,500 and they'll be out there with a checkbook wanting to buy-that sucker. But for \$5,000, they will say, "Man, there is something wrong if that is all you are selling it for. I don't want anything to do with it." A Country Club has maybe a \$3,000 to \$5,000 initiation fee and they have a waiting list. You have any waiting lists to get in any of your Lodges up here? Boy, we don't. And we probably never will.

History Nights have helped us; believe me I know because we have been trying it - it takes a little while. You are not going to see a big surge in one year. Another thing along the same line, if you lose Entered Apprentices. I believe a lot of it is their treatment. We always think of the Third Degree as the big night. Isn't that what most

people think about it? That's your big night in Masonry. Actually your Entered Apprentice night is your big night in Masonry. You are bringing a person in there, this is his first exposure. If you ever want to make a good impression, give him that night. Get him included, talk to him, don't let him sit out there alone and wait for someone to come out and say okay, you're next. You take him in there, and the guy is half scared, he doesn't know what is going to happen to him. Then you undress him and that doesn't help him any. Then you wonder why in the name of Heavens he doesn't come back and see what you are going to do to him next. We tell them in our lectures in our Entered Apprentice Degree. Man, when I took it, that paragraph wasn't in there and I thought about it. Oh boy, am I getting into something. The next paragraph says the only penalty that Masonry can give is reprimand, suspension, or expulsion from the Order. And that would normally put a person at ease. Of course, this is after he has been through this, but this is in the lecture. And you tell him you are not going to cut his throat, things like that.

We haven't gotten around to doing all these things yet, even in my own Lodge. We have talked about them, but talk is cheap. It takes work. Anything worth having has to be worked for. That's what this amounts to, and these things will undoubtedly help, and you will see it growing. If you thought when you started the Grand Lodge of Alaska you didn't have many Lodges, why the Brethren of Nebraska had three Lodges and a lot of us thought you had to have four; we did in Wyoming. We had a membership of 200 when they started that. And like you say, you're rich up here, your membership and the growing Lodges that you have, Grand Lodge Officers line and everything. You are on your way. No way are they going to stop you. And all of you people in here are interested in Masonry or you wouldn't be here.

Think of the one Man, the one Man that made the biggest change in everything that had happened 2000 years ago. He had twelve Disciples. How many have you got here? Over 100, so you should really be able to get out and spread some enthusiasm. Spread the word about your Fraternity and you ought to grow without any problem at all. I would imagine the people coming in up here, some of them I know, one of them from our Lodge in Glenn Rock, our Master, is working in Valdez. I talked to the Master here about him and he knows him and is going to move his family up here. He is really excited about Masonry, all of it, and he belongs to all of it. But these disciples that you have each do a little bit. You can't help but come out ahead on it.

I would like to thank you, Brother John, for all the courtesies. I enjoyed myself, and I am glad I came. I tried to talk my wife into coming, but she said, "I'm not going up there and freezing to death." It's probably colder in Casper than it is here. She said, "I'll take the same amount of money you spend going up there and spend it on something I want." Boy, are you lucky I can afford you! But I have enjoyed it, and sometimes in the future I will be back up here, probably in the summertime when she won't freeze and spend some time. Thank you again.

# MW Alexander S. Mitchell, Past Grand Master of British Columbia

Thank you. Brother John, Brethren All:

I have just been sitting here today listening to knowledgeable Freemasons and the ideas they have conferred to you and me. Brethren, I am not going to delineate any further by getting you mixed up in any way we might promote Masonry in British Columbia. I think today that you have had many ideas, knowledgeable and profitable, suggested to you and far be it for me, Brethren, to suggest some of our ways to get you a little mixed up. I, myself and I know a few Canadian friends that are with me, RW Brother Morehouse and RW Brother Douglas, if you will please stand. These two Brothers came up with me, Brethren, and I assure you that between the three of us, we will be able to take back many, many ideas that have been put forth today. Thank you very much.

As I said, I am not going to discuss Masonry at all. But I am, in the absence of the Grand Master of British Columbia, MW Brother Douglas Philps, bringing you the greetings, RW Sir, of the Grand Lodge of British Columbia. All the Grand Lodge Officers and Members send you heartfelt greetings for a wonderful session that you are carrying on today, and a really good future for you. I don't see any difficulty ahead for the success of the Grand Lodge of Alaska. I think. Brethren, if we can visualize the Grand Lodge of Alaska working as a football team, and at this time I would like the Grand Secretary to stand up. I ask you, brethren, to take a good look at the physique of this man, and the Grand Master's staff sitting around here. I'm sure they are envious of you, RW Brother Ingram, because in your Grand Secretary we have a terrific man there who I am sure can tackle any problems that you may come up with.
