

MESSAGE OF THE MW GRAND MASTER

To The Most Worshipful Grand Lodge of Free & Accepted Masons of Alaska:

Welcome to the Eighth Annual Communication of the Grand Lodge of Alaska. To those of you who have never been in Fairbanks before, it gives me even more pleasure to welcome you to my home town. It is a great place to live and it's great to see so many new faces in attendance at this session.

I have seen many of you throughout the Continental United States as we have visited other Grand Lodges; and again, I welcome you to Fairbanks.

To those of you who have never attended a Grand Lodge session in Alaska we do things a little different up here. We try to have fun as well as take care of serious business.

NECROLOGY

Thirty of our Brothers listed below passed away during 1988 and we shall miss them. We share their loss with their families.

Our Grand Chaplain, Worshipful Brother John W. Edgar, will conduct a memorial service later during the communication.

STATE OF THE CRAFT

Having visited each Lodge in our jurisdiction and having spoken to all those present, I had the opportunity to share many of the problems which you have expressed. I sincerely hope I was of some aide to each of you. Some of those problems expressed will never be solved until such time as we sit down and ask ourselves how important the degrees of Freemasonry are to each of us. Do we really value them as we say we do, or are we just voicing empty words to each other?

I think the time has come in this great Fraternity for each of us to increase our efforts to attend Lodge regularly, conduct ourselves as Masons, and love one another as we profess we do. Let us work together to strengthen our Lodges and the precepts of Freemasonry.

As many of you know, we began a new program for the Grand Lodge of Alaska in that we conducted District meetings. The idea for the District Deputies was to hold a meeting in their respective districts this year, and thereby attempt to get a better interchange of ideas, problems, and solutions. I am very pleased at the overall outcome of these meetings we held this year. As in all things new, there has to be a learning process of trial and error. I am positive that next year they will be even better than this year's programs.

Thanks to all three District Deputies who took part in this program and "blazed the trail," if you will, in this new endeavor.

In my travels to each Lodge, financial questions were always asked concerning certain Lodges, and one of the glaring weaknesses is that most Lodges do not have a Dues Review Committee to look ahead for trouble, and to make timely bylaw changes for Lodges to keep them on solid, financial footing. In none of the Lodges that were having trouble did they have a Review Committee. I strongly urge that each Lodge Master appoint such a committee to constantly monitor the dues structure. If the Grand Lodge has to increase the per-capita in any way, shape or form, the Lodges will be geared up to handle the situation with bylaw changes.

Since we're talking of financial problems with Lodges, another thing that came to mind in my travels in discussions with the various officers, was that none of the Lodges had an operating budget. I think for any Lodge to be successful in handling its financial problems, it should have an operating budget. The budget should not be cast in concrete where the members can't work with it and make transfers of funds from one line item to another if need be. But, at least, the members would have a handle or an idea of where their money is going and how it's being spent.

I think in the future it might be a good idea to submit those budgets to the Finance Committee for its review and probably any suggestions it might make to help the Lodge officers come up with a workable budget. This is something to take into consideration.

As you know, this year we created a Grand Lodge Degree Team. The degree team will be in full costume under the direction of our Grand Lecturer, Very Worshipful Howard Hobbs. The team has had some exposure, and I think it is great. They were to confer the Third Degree yesterday at the Fairbanks Masonic Temple, and I hope you were able to attend.

I was asked at the beginning of the year why I wasn't as concerned about the overall function of the individual Lodges as I was about the Grand Lodge. Well, I've always felt as a Freemason knowing what my obligations are and knowing the obligations of the Masters and Wardens, and the character of the Past Masters, that the Lodges would function fairly well and take care of themselves because the officers are not going to let the Lodge fall apart. So, my big concern, although I'm concerned about all Lodges, wasn't to concentrate on the Lodges, but to concentrate on Grand Lodge. Having served as Chairman of the Finance Committee for one year prior to my election into the Grand Lodge line, and being an ex-administrative officer for the State Jail here in Fairbanks, and working with budgets for 14 or 15 years, it's very apparent to me that our current operating budget is too austere. In fact, it's an embarrassment. I think that we have to look at things realistically and not worry about what other people are going to say: "Lookie there, they raised their per-capita tax." But we are working under an absolute bare bones budget. We can't afford a salary for the Grand Secretary or a reasonable amount of money for his travels or for that of other officers; we can't afford any of our charitable functions, adequate Grand Lodge office quarters or equipment, or to

provide as much of a service to our Lodges as we should. We ought to be able to call our Grand Lodge Officers, Lodge Officers, and committeemen together for training and education more often than once a year at the annual communication, but we can't afford it. I think the time has come to look at our per-capita tax, and I think it absolutely has to be raised this year. You can do it in increments or you can do it all at one time. Based on my meetings with the Finance Committee, I feel we need to raise our per-capita by about \$5.00 per member.

Now, there are two ways of doing this: 1) a flat \$5.00 raise, which could cause a hardship; or, 2) to raise it in increments of \$2.50 one year and then two years later raising it another \$2.50; or raise for two consecutive years. In either case, we have to look at that per-capita very realistically. We just don't have the money to continue operating with the budget that we had four or five years ago. We haven't raised per-capita for eight years, yet commodities have increased. Postage has increased, telephone costs have increased, and we're renting office space full-time. We have to look at those things.

During this year, your Grand Master, with the help of the Jurisprudence Committee, formulated some bylaws and rules to govern Masonic Clubs within this Grand Jurisdiction. The purpose of this was to standardize the operation of all Masonic Clubs. As you know, based on our population density here, there are small communities that need some Masonic intercourse but don't have enough members to start a Lodge. We approved a set of bylaws that essentially parallel those governing a Lodge with the exception that none of the clubs can perform degree work. They can practice their degree work in a tiled room but if they have a candidate for the degrees of Masonry, they must bring him into a chartered Lodge. Each Masonic Club is assigned to a Lodge for supervision. This way if a club does dissolve all the assets are returned to the Grand Lodge. These bylaws for the government of Masonic Clubs are on file with the Grand Secretary. Those of you desiring to see them, just ask him.

During this Masonic year, I appointed Worshipful Brother Leslie Little to develop an index for the Alaska Masonic Code to make it easier to research material. I have a copy of it and I must commend Brother Little for doing an outstanding job. Thank you, Brother Les.

Very Worshipful Brother John Grainger, a member of White Pass Lodge No. 1, has worked very hard for the Grand Lodge of Alaska. He is also acting as my personal representative in Southeastern Alaska to help form a Masonic Lodge at Thorne Bay on Prince of Wales Island. They hit a rough spot and they're having trouble getting some of the brothers proficient so they can petition for dispensation. So, Brother Grainger has been thinking about forming a Masonic Club in the interim. Anyhow, based on his dedication in his travels and other work for the Grand Lodge of Alaska, I appointed him a Deputy of the Grand Master in District 4. Welcome aboard John, and I know you'll do a great job.

ORDER OF DEMOLAY

This year, during the month of October, I had to issue an Edict which was very, very hard to do in that it was directed against one of our Brothers. This Brother was the Executive Officer in Alaska for the Order of DeMolay. The problem started in 1985 when the Executive Officer and the DeMolay had a Leadership Training Conference in Wasilla. They had rented the campsite where they were staying for \$5,000. Based on the registration fees and other monies available, they had enough money to pay for this campsite use. Instead, the Executive Officer paid \$500.00 down and secured outside speakers for whom he paid travel expenses with the remaining \$4,500.00, leaving the campsite fee unpaid. A judgment against the Order of DeMolay was obtained in Small Claims Court in 1987, a matter of public record. In the meantime, two Grand Masters before me tried to resolve the situation and even made recommendations to the Grand Master of DeMolay to remove the Executive Officer. Nothing was done. On Wednesday, September 28, 1988, a meeting was held in Anchorage with the Advisory Council of DeMolay, the District Deputy, the Master of Anchorage Lodge No. 221, and myself. Prior to the meeting, I was told that the Executive Officer would be present so we could resolve some of these problems. The Executive Officer was not in attendance, and after listening to all the Brothers and the information they had, it was discovered that the Advisory Council had raised money in 1987 to pay for registration for the Leadership Training Conference and had a \$1,000 surplus. The Council told the Executive Officer that they wanted that money to be used to retire the outstanding debt owed by the Order of DeMolay. The Council members encouraged and recommended to him that he not obtain any outside speakers this time. I was informed that he nevertheless obtained speakers and paid for their hotel and meals with the surplus \$1,000. Consequently, the debt was still not retired.

In the meantime, the Executive Officer had rejected offers from the Grand Master of DeMolay and two or three Lodges in Alaska to assist in paying off the debt. I felt that this kept the Masonic Family continually exposed to public criticism. We don't need to be criticized for actions within the Fraternity.

Subsequent to the September 28th meeting, and while still in Anchorage, I had telephone contact with both the Executive Officer and the Grand Master of DeMolay. In my conversation with the Grand Master on Wednesday evening I brought him up to date. By this time I was very upset with the Executive Officer and told the Grand Master of DeMolay that if he didn't resolve the situation, I would; that I would issue an Edict to bar all Master Masons from attending any function of DeMolay. The Grand Master reaffirmed that he had previously offered to pay the debt.

The Executive Officer explained his absence from the Wednesday meeting by saying he was told it was to be a "witch hunt" and he had no intention of attending that kind of meeting. He did agree to meet with me Thursday afternoon but failed to appear at the appointed time. After two hours I phoned him at his Wasilla home and was told he'd decided not to meet but would do so in Fairbanks the following week. The Executive Officer did not attend that meeting either.

I issued the subject Edict, barring all Master Masons in the State of Alaska from attending any function of DeMolay until such time as the problem was resolved. On October 31, after being informed by the Grand Secretary that the Grand Master of DeMolay had accepted the Executive Officer's resignation, I rescinded the Edict, reinstating the welfare of DeMolay for the state and encouraged all Master Masons to again wholeheartedly support the Order of DeMolay.

That problem has been resolved. I felt badly about having to issue an Edict because I feel that the Supreme Council of DeMolay should have handled the matter. However, the problem had existed for so long that I decided action had to be taken.

RECOMMENDATIONS

- 1. To approve carryover Resolution No 88-5 which would permit amendment of the Standard Work upon approval of Grand Lodge.
- 2. To approve an increase in the per-capita tax for this Grand Jurisdiction.
- 3. To amend Section 2.01 of the Alaska Masonic Code to reflect that all Grand Lodge Officers holding elective office will carry the title for life, of the highest office to which elected. Currently the code does not address this.
- 4. To transfer the AMRA Gold Pan money to the Grand Lodge Permanent Fund and administration of the program to Grand Lodge with its present administrator. My rationale for this is that the Gold Pan Program is dormant and the revenue is subject to income tax. If in the Grand Lodge Permanent Fund, the revenues would be tax exempt. Implementation of this recommendation would, of course, be subject to whatever decisions were made at AMRA's 1989 Annual Meeting.
- 5. To amend the code to provide that only the interest and not the principal in the Grand Lodge Permanent Fund could be withdrawn for other uses. Also that the Permanent Fund monies be invested in such a manner that they can be easily identified as separate from the General Fund. This would also enable the brethren who are working to raise the money to see the fruits of their labor at each Grand Lodge by seeing the Grand Lodge Permanent Fund increase and also identifying the interest that may be available. I think this is important for the continued health of that program.

ANNUAL REPORT OF THE GRAND SECRETARY

To The Most Worshipful Grand Lodge of Free and Accepted Masons of Alaska:

The following report is submitted pursuant to Section 3.05 of the Alaska Masonic Code.

The 1988 Masonic Year had its ups and downs. We lost members; our financial status could have been better; and workload demands on a "one man show" precluded some important accomplishments, notably the compilation and printing of more Proceedings of our previous communications. The postage increase in April dictated some burdensome operational changes to keep costs down. New records were established for North Pole Lodge UD.

In most years it is barely possible to squeeze the compilation of statistical and financial data from Lodge reports, the work of our accountant, professional typist, and printer all into four weeks to have the Grand Lodge reports ready in time for the annual communication. This year the calendar compressed that time period down to three weeks. Accordingly, the Lodge Secretaries were advised in writing and sometimes reminded verbally of the mandatory January 10 deadline. With one exception they rose to the occasion and the necessary information was provided, some by telephone, by the deadline. Code Section 3.05 does require me to report that the October, November, and December monthly reports and the End of Year report have not been received from Mt. McKinley Lodge. However, this is an "excused absence" because of the lengthy and very serious illness of the Secretary.

Requests for recognition were received from two more Grand Lodges and referred to the Fraternal Relations Committee.

The reorganized Alaska Masonic Code, approved by the delegates to the Seventh Annual Communication, complete with index and three ring notebooks, was received from the printer and distribution begun. Complementary copies were sent to our 16 Lodges for their elected officers and the rest put on sale.

Permanent Fund donations during the 1988 calendar year totaled \$5,391. This consisted of \$2,440 from Tanana and Fairbanks Lodge fundraisers presented at Nome last February; \$1,501 from Glacier Lodge fundraisers; \$1,000 from Mrs. George Tremper, widow of a Tanana member and active Scottish Rite Mason; \$400 from Tanana Lodge in memory of four deceased members; and an individual donation from Brother Neil Harper of Glacier. An additional \$245 was received in January 1989 from a Kenai Lodge fundraiser and an individual donation by Brother Allen Scouler of Kenai Lodge. Permanent Fund activity is again reflected in the Assets chart.

My visitations this year included a number of our Lodges, the Grand Secretaries Conference in Cedar Rapids, Iowa and the Western Conference in Seattle, as well as the cornerstone laying in Fairbanks.

A project was undertaken this year to review all dual or plural memberships. That job has been completed for such members within Alaska. The data are in from other Grand jurisdictions but the job of correcting our records on these Brothers is not done. However, among the rather interesting things uncovered were a number of Alaska members who have been dropped for NPD in their out of state Lodges and must now be dropped in ours. I also discovered an Adak member who had been expelled from

Masonry by his Lodge in Washington in 1987. That expulsion is reflected in the Status of Lodges chart accompanying this report and is not the result of a Masonic trial in Alaska.

Statistically our figures are complicated by the addition of 31 members in North Pole Lodge UD after the year began. Our net loss of 48 members (shown in the chart) from our March 21 high is softened somewhat by the additional North Pole Brothers. Essentially we lost 17 members from our January 1, 1988 total. Our gains in terms of proficiencies about equaled those in 1987 but affiliations as dual members were only about a third as many. Oddly enough, our degree activity was higher than in 1987. We lost only half as many members by death but this was offset by double the number of NPD's.

These statistics also have a direct bearing on our financial structure. Our estimate of income from per-capital assessment was close but that from degrees conferred and affiliations was too high due to the much reduced number of affiliations during the year. Receipts from petitions for the degrees were only half of our estimate; this would appear to indicate that the increased degree activity involved those Brothers who had petitioned in previous years.

As shown by the charts on pages 21 through 25 (ed. Note: In Blue Book), very little money was left on the table and our total estimated available funds dropped by \$25,000 over 1987. We stayed at or below budget in nearly all line items. Except for dues of \$52 to the Conference of Grand Secretaries, all expenditures are reimbursed by those attending the Grand Masters and Grand Secretaries Conferences. These reimbursements are not always received in the same year as that in which the money was originally advanced by Grand Lodge; hence the apparent overage. The overage in Cost of Masonic Materials reflects the unbudgeted cost of new Alaska Masonic Codes, approved by the Finance Committee.

Insurance premiums on paraphernalia dropped, but some of this reduction also reflects a one-time change in accounting methods.

On the recommendation of the Finance Committee \$15,000 was withdrawn from the Permanent Fund account and three \$5,000 TCD's, with staggered maturity dates, were purchased to obtain better interest rates.

Every possible way of keeping costs down is employed to the point of being miserly. However, we cannot operate without the Postal Service. I avoid the telephone like the plague and rarely call other Grand Secretaries, even though that contact is so much better in some instances. Even so, most mandatory phoning is within Alaska to officers or Lodge Secretaries and rates within the state are exorbitantly high. Very little commercial printing is done and our image shows it. No professional typing is used except for the annual reports. Most of our costs of doing business are uncontrollable. I firmly believe that we have lost high caliber talent as Grand Masters because of our inability to offset required expenses from personal funds of \pm \$15,000 over the four year

period they progress through the line. Withdrawal from those organizations to which we have to pay dues is unthinkable.

Again, I thank the Lodge Secretaries, Grand Lodge Officers, and committeemen for their cooperation. Please support, your Lodge Secretary; he is the backbone of your operation.

REPORT OF THE FRATERNAL RELATIONS COMMITTEE

1st Report

To The Most Worshipful Grand Lodge of Free and Accepted Masons of Alaska;

The assignment of the Fraternal Relations Committee is to examine the printed or written proceedings or other documents emanating from the Grand Lodges and report at the Annual Communication whatever may seem of sufficient importance and of interest to the Craft. The Fraternal Relations Committee shall deliver a copy of these reports to the Grand Secretary prior to the Annual Communication of the Grand Lodge. Also, the Fraternal Relations Committee shall review all requests for recognition from other Grand Jurisdictions and as appropriate, recommend recognition of the particular Grand Jurisdiction or rejecting the said petitioner or petitioners. I agreeably accepted the assignment, the Fraternal Relations Committee did examine all correspondence received and report as follows:

New Lodges in the different jurisdictions that we were in contact with, ...(about seven seconds of missing information on tape) ...daylight lodges, meaning that they meet about noon. The Grand Lodge of England, issued charters to 47 new Lodges, and certainly not forgetting our newly chartered Lodge, Aurora Lodge No. 15. Increased percapita which is always a interest, I feel, of our Grand Jurisdiction, these different respective Grand Jurisdictions starting with Delaware, increased their per-capita tax three dollars, Massachusetts increased from 12 to 15 dollars, New York increased from \$7.50 to \$12.50, British Columbia increased from \$9.00, up to \$9.00, Saskatchewan increased from \$12.50 to \$13.50 and New Zealand increased from \$11.00 to \$13.00. Each year, I kind of touch on that to let you know Brethren that lots of these jurisdictions have got that problem that we discuss each year here.

The Grand Lodge of Kansas held the first meeting of a Mobile Lodge, apparently a traveling Lodge, and the purpose of which was said to promote Masonry throughout the state and elsewhere, as occasions might require. From our Brothers in Japan, after 30 years, they have finally received official letter of recognition of the United Grand Lodge of England. And Brothers, we didn't in our wildest expectations think that we would get the Grand Lodge of England as rapid as we did, but it was through the indulgence and perfection of Jim Williams and Gunnar Flygenring my Brothers that we got it as quickly as we did, and don't ever forget that! That is why we didn't wait 30 years, because of these two, and others.

Now, we go to California, California received a report from the Grand Master that a special committee would investigate and report to the several Hawaiian Lodges on the feasibility of a Grand Lodge of Hawaii. And I anxiously await some kind of a reply on that, cause that is of interest to us, to see how they are doing.

Now, we will go to Oklahoma - Just a "pick'in and a'grin'in "- the He-Haw Star, Brother Roy Clark was made a Mason on sight on the 8th day of December by Grand Master James E. Love and the Grand Lodge Officers. The Grand Master remarked how attentive to the degree work Brother Clark was. We offer congratulations to Grand Master Love and the Masons of Oklahoma, for bringing a highly respected and sincere man as Roy Clark into our fraternity.

Mexico, Brother Jarnmie Crocks of Laredo, Texas has been appointed secretary of the Fraternal Relations of the Confederation of Mexico Grand Lodges. The Commission on Information for Recognition of the Conferences of Grand Masters of North America consider all Grand Lodges in Mexico worthy of recognition. The most likely reason why many of the Grand Lodges in Mexico are not recognized, is laziness in the translation by the Masonic Mexican Brethren. I feel that!

New York, the Grand Lodge of New York presented the distinguished service award to General James A. Doolittle, a former Alaskan, remember? Also, New York again voted down a proposal to lower the petitioner's age from 21 to 18.

Queensland, a circular on proper Masonic dress has been sent to all Lodges. In part, it read he, a Brother Mason, should be so attired as to express the dignity of Freemasonry; bright clothes does not do this! So any of you that visit those foreign jurisdictions, down under, they are pretty, pretty particular on their dress. And God bless them, we love it!

The Philippines, aha, the Philippines ruled that the title of Honorary Past Master could not be conferred upon a Brother in recognition of his long years of dedicated service. And at a Lodge, could not accept a petition of one whose petition had been rejected by another Lodge. Oh, how about that?

But, so goes these Fraternal Relations, lets go a little further.

Italy, at least ten Grand Jurisdictions of the United States, namely, Arizona, Connecticut, Kentucky, Iowa, New Mexico, Oregon, Pennsylvania and South Dakota, Tennessee and now West Virginia have withdrawn recognition from the Grand Orient of Italy for their failure or one of the constituent Lodges to display the volume of the Sacred Law when the Lodge is open. Last February, in 1988, the Commission on Information for Recognition of the Conferences of Grand Masters of North America reaffirmed its opinion, in 1986, and in 1987, that the Grand Orient of Italy is not now entitled to recognition. Information that we have received concerning the dispute between the commission, and it is only between the commission and the Grand Orient of Italy is that progress is being made to resolve the problem. It is the recommendation of this committee that the Grand Lodge of Alaska not get involved in the controversy at this time.

We have received a request from the Grand Lodge of Valle de Mexico for fraternal recognition and exchange of Grand Representatives. The Committee on Information for recognition of the Conference of the Grand Masters of North America indicates that this Grand Lodge according to its information at its disposal is regular.

Investigations by your committee also reveal that this Grand Lodge is recognized by all but just a few of the Grand Lodges in the United States. It is the largest, with 8,200 members of the Grand Lodges in Mexico. Its location is in Mexico City, and it has 202

Chartered Lodges operating under its authority. And that the requirements of our Section 45-bl of the Alaska Masonic Code are complied with. (Alaska Masonic Code contains only 34 Sections, however, Section 1.07, paragraphs 4 and 5 deal with the matter of proper recognition and procedure of Grand Lodges)

So, it is your Committee on Fraternal Relations recommends that The Most Worshipful Grand Lodge of Free and Accepted Masons of Alaska; accord recognition to the Grand Lodge of Valle de Mexico and that our Grand Master, at his will and pleasure, arrange for an exchange of Grand Representatives.

The Jewels of a Past Master and of the Officers of a Lodge are: Past Master - the Blazing Sun within the Compasses extended on a Quadrant, Master - the Square, Senior Warden - the Level, Junior Warden - the Plumb, Treasurer - the Crossed Keys, Secretary -the Crossed Pens, Chaplain - the Bible, Senior Deacon - the Square and Compasses united with a Sun, Junior Deacon - the Square and Compasses united with a Moon, Stewards - Cornucopia, Marshal - Crossed Batons, Organist - Lyre, Tyler - a Sword. The Deacons' rods are blue, and the Stewards' rods are white, each surmounted by its proper jewel in silver or white metal.

The color of their Aprons is white. The Aprons should be of lambskin, fourteen inches wide and twelve inches deep, and may have sky-blue lining and edging, with the respective emblems thereon.

Be Amended by adding the following paragraph:

A Past Master belonging to a lodge of this Jurisdiction may purchase and wear the Past Master's Apron as supplied by the Alaska Masonic Research Association. Said Apron to show the outlined of the State of Alaska in blue, the 'Eight Stars of Gold' of the Alaska State Flag, and the Past Master's emblem.

NOW, THEREFORE, BE IT RESOLVED, that the second paragraph only of Section 18.20 of the Alaska Masonic Code, which now reads:

In addition to the fee for the degrees fixed by the Bylaws of the Lodge, a fee of fifty dollars is required as a contribution to the general fund of the Grand Lodge.

returned upon written request therefore. A record of the name of the affiliate and the date of his election is transmitted to the Grand Secretary within one month after the election of the petitioner to membership.

A Lodge may receive a petition for affiliation if it is accompanied by an affiliation fee of at least thirty-five dollars and a proper dimit or a duly certified copy thereof (or a letter of good standing pending receipt of such dimit) from the Lodge of which the petitioner was last a member in accordance with the provisions of Section 17.03 or 17.05. Until its first reading at a Stated Communication, the petition and accompanying fee may be withdrawn or returned upon written request therefore. A record of the name of the affiliate and the date of his election is transmitted to the Grand Secretary in the monthly report of the Lodge Secretary. Thirty dollars of the affiliation fee must be paid into the Grand Lodge General Fund.

To The Most Worshipful Grand Lodge of Free and Accepted Masons of Alaska:

Finance

Report of the Finance Committee

1st Report

To The Most Worshipful Grand Lodge of Free & Accepted Masons of Alaska:

The Finance Committee spent a considerable amount of time in analyzing and evaluating the financial condition of Grand Lodge which, of course, indirectly has a relationship to the financial condition of the individual Constituent Lodges. Further, as admonished by last years Finance Committee, we have given serious consideration to alternate sources of income.

During one of our earlier meetings, we developed some recommendations for modifications in the internal handling of financial data, which recommendations were subsequently adopted and revised procedures instituted by the Grand Secretary.

The Grand Secretary submitted a request for a budget line item (Printing) increase of approximately \$1,200 - to accommodate additional cost due to the reprinting of the Alaska Masonic Code, which request was approved.

Further, the Finance Committee was asked to consider a proposed bylaw amendment from Valdez Lodge No. 4, with reference to establishing a life membership plan in the said Lodge. While the members of the Finance Committee are very much in favor of life membership plans, if properly conceived and administered, we found ourselves unable to approve the proposed bylaw amendment due to a major flaw in the proposed administration of the plan and returned it to the Lodge for further consideration and revision.

As a result of analyzing the financial status of the Grand Lodge, and the records associated therewith, the Finance Committee developed the following recommendations for consideration by the Grand Master and/or Grand Lodge:

1. That each Constituent Lodge be encouraged, if not required, to prepare an annual budget showing, in the least, the projected income and expenses for the Masonic Year under consideration - with a view to knowing at a sufficiently early date, whether it can

- reasonably expect to operate 'in the black' or whether some action needs to be taken to insure that it will.
- 2. That alternate sources of income for Grand Lodge preferably from outside the fraternity be sought and developed in order to help lessen the impact from "income shortfall" experienced by Grand Lodge.
- 3. That, as it is becoming increasingly evident that the Grand Lodge expenses are rising at a much faster rate than its income and that alternate sources of income cannot be relied upon to 'pick up the slack' consideration be now given to an upward adjustment in the per-capita assessment.

Difficult as the decision to raise the per-capita may be, it appears to be the only immediate solution to insure that this Grand Lodge remain financially strong and viable. Grand Lodge needs more revenue - either more from each of the current members, or, in the alternate, a great number of additional members with the current rate per member remaining stable or possibly, of course, a combination of the two.

While considering three separate, proposed, operational budgets for the 1989 Masonic Year, the Finance Committee, unfortunately and reluctantly, had to settle for and could only approve the proposed Budget, as contained in the Grand Secretaries Report, due to the limitation of projected income, even though each of the other budget proposals was deemed considerably better and more responsive to Grand Lodge needs.

Now Brethren, the preparation, and consideration for annual budgets is difficult under any, under any circumstance and it is quite the same in Grand Lodge. We have given considerable consideration to the operational needs, the financial situation of not only the Grand Lodge, but also the Constituent Lodges, to the extent that we were aware of it, and we developed three separate proposals for your consideration. Now, those of you that are familiar with our Grand Lodge environment - you are aware that the Grand Lodge office is a room of about 120 square feet. I have got a bathroom in my house that is larger than that. Now in that Grand Lodge office, we have a desk, a chair, a few filing cabinets, a book shelf and we have got packs and boxes stacked on top of the filing cabinets. In addition to that, the Grand Secretary has got a number of things stored at his garage, and at his house, and I have nine large cartons stored in my basement. Now, we feel that after eight years of operation, this Grand Lodge should have come of age. There are a number of things that in our opinion, that this Grand Lodge needs to do and certainly one of them is too provide for the future. If we do not deal with it now, it may be too late.

It is important that this Grand Lodge remain viable, while it is true that this past years operation did yield a small amount of excess revenue over expenses, there, it was because of a couple of things happening during the year. In addition to just a good conservative management, we did go from a largely cash basis handling of the insurance premium to an accrual basis, and hence the insurance expense for the year 1988 is lower by some \$900.00 than would otherwise be the case. In addition, there was an unusual income of some \$1,200.00 from the Anvil Lodge No. 2 as a result of last years Annual Communication. A donation like that back to Grand Lodge is an unusual rather than a

customary donation. In addition to that, there were some slight overstatements in anticipated costs. For instance, we had assumed that the printing of the proceedings for the years prior to the current Grand Masters year would have required \$7,500.00 to complete. They have basically been completed through the year 1987, and there possibly remains another \$300.00 to finish out 1987. So consequently, the budget for the coming year has been established merely to take care of the proceedings from this communication right here.

With that, I would like to go into the first of the three budget proposals. This is the budget that we feel that this Grand Lodge should be able to support at this stage of its development. Now there are four major items on this budget proposal that you have not seen in the past. The Grand Secretary for some time has been working under some stress in trying to care of all the minute details by himself. Even though in past budget proposals we have provided for a couple of thousand dollars worth of occasional labor, the Grand Secretary has been unable really to utilize it because of, from occasional labor, he would have to spend so much supervisory time, that in essence it would be self defeating. His feeling that the items might just as well be done by him, has been explained to several different persons possibly throughout the year in order to get it accomplished, so, to that extent, the occasional labor has not been utilized.

Now, we feel that it is important for the Grand Secretary to operate in the Grand Lodge office rather than out of his living room, however, it has not been possible because there isn't room, it is not adequate and he doesn't have the equipment to work with. What we have in the Grand Lodge office today is what we put in February 1981. That isn't to say that there may not be some service life left in it, but the time has come when we need to expand, we need to improve on our facilities. We have therefore included in the 'should have' budget proposal, we have provided for enlarging our office facility from some 120 sq ft to somewhere between 500 and 600 sq ft, at a commensurate increase in cost. Right now, we are paying \$200.00 a month for the office rental, we propose to go to \$600.00 and feel that would get us between 500 and 600 sq ft of space. In addition to that, we have also provided for a a part-time, permanent employee on the basis of four hours a day, for the entire year, at a rate of \$6.00 an hour. That would take up roughly \$7000.00 to \$7,200.00. That would still leave another \$500 to \$600.00 in that account for the occasional labor that might be needed from time to time. Of course with a payroll of some \$7,000.00, there are other associated costs with it as indicated on here, there are payroll costs of about \$950.00 for the payroll taxes.

Now, we have been remiss for many years in that we have not provided or allowed for any expenditures outside of the fraternity itself. A few years back, we did have an allowance set up in one of the budgets for charity, however, before the year was over, we found that we did not really have the money to spend on charity. We needed it for something else, so consequently the charity was never granted. We feel that is important, that we do provide something in our operational budget for charity. The budget proposal before you has got such an amount in it.

Another area where we might have been a little lean in prior years is to provide properly for the Annual Communication. Now in this past years budget our Annual Communication expense and reception of visitors total roughly \$2,500.00 and we had a total of \$3,000.00 set up, so we were within the budget on that but we also did not expend some of the funds that probably should have been done in order for us to remain on a par with other jurisdictions. So we are proposing an increase in either Annual Communication cost, or the 'reception of visitor' - it really amounts to one and the same thing overall. There are a number of other considerations, such as the insurance It is true that our paraphernalia insurance cost was reduced a little bit this year, but the liability portion of it is still about the same or increasing, and we have to continue to provide for that, Printing costs are an item that is up and down, some years we need more than others depending on the supply of forms in house. Printing of books and things of that nature for resale does not show up as printing costs. It rather shows up as inventory and then when the items are sold, it shows up as the cost of the sales and the net difference as the excess as hopefully the sales price over the cost of providing them. And that is properly accounted for this past year. It amounted to some \$174.00 and generally, we have averaged a projection of \$250.00 net revenue over cost and we have not achieved it.

I think basically what you see on the screen here portrays what we envision as a "should have budget" for a Grand Lodge of this size at this stage of its development. Yes, it is considerably more than has been provided for in the past, but it is something that the Finance Committee feels not only is necessary, but also is within the means of the individual Lodges and/or members to consider.

Brother Ray, may I have the center slide right now please for the summary? Now, there is the summary section of what you just saw on the other two projectors. It does indicate an increase over the 1988 budget proposal from \$36,000 to \$49,200 or almost a \$13,000 increase. Now, what this also relates to is the fact that our annual income from sources other than per-capita is averaging \$12,000 or less - so if you subtract the \$12,000 from roughly \$50,000 - you windup with roughly \$38,000 which should come from per-capita, and mat translated into 1,900 members, reads roughly \$20 per member. So if this budget proposal was to be considered, and we feel it is a reasonable budget proposal, it would undoubtedly entail a rather drastic increase in the per-capita unless some "God-fairy or sugar-daddy" could be found that would just annually donate us the difference. And in the past, that has not been the case. We have had lots of promises of donations over the years and very, very few of them have ever materialized and it certainly is something on which we cannot rely. The only way we can manage it is to have control of our own destiny, the only way that we can do that is to have some kind of specific formula for gaining the revenue and the income. And, per-capita probably is as fair if not fairer than any.

So with that, we will now go to the, yeah, turn it over now please and go to the other two again. Now, what you have just seen was the budget proposal that we feel this Grand Lodge should have, could have, and can afford. When the Finance Committee went through its several meetings trying to develop the budget for this year and the analysis of the past years records and the history since 1981; we developed the budget

proposal, yeah, that you currently see on the screen. This was done by the Finance Committee without any reference at that time to the projected income for 1989. We just went through to compare what we thought might be the case for 1989 compared to the 1988 proceedings and procedures and we determined, based on information available to us basically through the third quarter of 1988 that this was the budget that we could support.

However, you are seeing on here that there is a reduction from 1988 even though section one of the budget shows a 4 percent, I mean a \$4,000 reduction. Section two indicated an increase in subsection items of some \$2,300, so there was still a net reduction in in expenditures as compared to 1988. So we felt pretty good at that point. Now there are some items in here that may be noteworthy, as I have already stated earlier, the printing and binding of the proceedings has been reduced from the \$7,500 which in essence tells us two years and then a clean up on three other years, so the \$2,500 seems to be a legitimate amount containing about \$300 to fuel, to finish up 1986, 1987 and about \$2,200 to take care of the 1988 year. Other than that, I believe that the items on here are fairly explanatory.

The office supplies and expense in the past has contained the rental expense, so you will see that we have broken it out and therefore show a reduction of \$2,400 in office supplies and expense and an increase in the rental. That is merely to pinpoint where some of that money goes.

Now, the depreciation, we find we are almost fully depreciated on a number of the items and we have reduced the depreciation expense which of course, is a paper transaction only. There is no cash involved in it per se, but we have reflected that to its more current level of \$1,500. However, you might say that even though there is no cash associated with a depreciation, ideally, we should have been able to fund our depreciation expense so that we could begin to replenish or replace rather some of the items that now need replacement. You will recall that we did not start in 1981 with new furniture, everything that we had was borrowed, begged, or almost half-way stolen. A lot of it was military surplus that was repainted to look like something that would fit in an office environment. It was copy clean when we got it. So we did a lot to, you know, to make use of everything we could get hold of, and the time has come when we need to get some replacements. The typewriter currently in the Grand Lodge office is one that I had when I was the Grand Secretary. I left it. I donated it to the Grand Lodge at the time, it was probably 10 or 15 years old at the point when I brought it in and it is alright for doing labels and maybe an occasional card, but it is no good for correspondence. To show the austerity of the Grand Lodge operation, I also wish to inform you that we are making use of old stationery also, and old envelopes. A lot of the mailings from the Grand Lodge really are not worthy of a Grand Lodge mail out, they are things that have been left over from other organizations and operations, merely with a new mailing label put across it; and it doesn't really look that professional and it does not do justice to what we feel that this Grand Lodge should stand for. However, in the interest of economy, we have made use of it, we are still doing it, but we sure would like to see the day when we can live on a par with the other jurisdictions.

Now if I could have a summary on the center one, please. As you see here, we have a total overall net reduction as compared to the 1988 budget proposal. Now, when we develop this, as I said before, we did not have the benefit of projected income and we thought that this one that we would have no problem supporting at all. However, when it came down to project the income for 1989, we found that we could not even support that austere program. So, if you will kindly remove that summary now and give me the center one there. I apologize for this makeshift operation, we had planned it entirely differently, but due to some local missed communication we did not have the equipment and we did not have the proper location for it, so we will have make-shift it, but we hope that the message will still get across and you can see what we have been dealing with.

Now, when we looked at the income - the projected income for 1989, we found that what we had referred to as the austerity program, which was merely an attempt to stay fairly current to 1988, could not even be supported by the projected income. We found that we had a shortfall of about \$4,960 some-odd dollars shortfall. We did not want to come to this communication showing deficit spending, and consequently, we did not feel that we could submit what we felt was already the austerity budget for consideration by this Grand Lodge - merely because of the lack in projected income. Consequently we started with a very sharp knife and the Grand Master assisted us as the Deputy Grand Master in trying to find areas where we might do the least harm. There is no question that that harm is going to be done, but in the interest of showing some fiscal responsibility, we decided none-the-less to cut the budget. So you can see the areas where we cut back from the previous one in order to merely present a balanced budget. As you see, it is \$5,000 under the projected expenditure for the year 1988 and that is a substantial reduction in an already austerity program.

We have left the rental the same. One item that was in both the first section and also in this program here is some monies allocated for professional expense. We have found that we have definitely arrived at a time when we have to provide some funds for, not only accounting professional advice, but also for legal advice - specifically legal tax advice, and on the first slide that we put up, a thousand dollars allocated there. I believe that it was a thousand on the second one also - on this one here, we cut it back to \$500 which may well turn out to have been already spent. I am not sure, but it is going to go over the projected amount. I don't think that there is any doubt about that. We need that in order to keep this Grand Jurisdiction out of legal tax tangles and to stay on the straight and narrow.

The Grand Secretary is utilizing advice and help wherever he can get it but the time has arrived when we must buy some professional advice.

Again, I believe that everything on there mostly is self explanatory so I would like to go to the next one. Now, you will see the comparison or the three separate budget proposals; on the one slide and on the other, you will see the projected income for 1989.

That was a summary of the other. I think that we have pretty well covered that Ray if you can remove that center one and go to the other two. On the screen now you

will see the three separate budget proposals in summary form. On the left hand screen and on the right, you see the projected income for 1989 - now I would like to specifically address the right hand screen at the moment - as you understand, of course, this was done prior to year-end and we were working at best with incomplete information and we had to do some projections from that time on. Since the end of the year, we have discovered mat instead of the, what had been projected last year as \$32,000 worth of income for the, for this Grand Lodge - we wound up with \$29,500. So, we were short some \$2,500 in projected income for the year 1988. Now, the amount for the degrees were fairly close together, we had projected in the previous year a \$1,000, we wound up with \$845 for the fees for the various degrees. Now, in this budget proposal here or this projected income, we have some \$5,500 for the fees for affiliation and for the petitioners for the degrees. Our total income last year in those two categories was \$3,670. We have \$5,500 in there. The difference being, that when we went through the process of developing the budget, we anticipated that we would be able to get additional funds from petitioners for dual membership and also petitioners for the degrees. It had been the admonishment by the previous years Finance Committee that we seek additional sources of funds, preferably outside the fraternity and that is what we did, so the \$5,500 that is, shown there, includes close to \$2,900 represented by the additional \$2,500 to be picked up for the petitioners for dual membership and affiliations and \$2,400, roughly \$2,450 from the petitioners for the degrees and that translates roughly in 20 petitioners for dual membership and/or affiliations at \$25 which is \$500 and 49 is how we arrived at it, based on more recent history; 49 new petitioners for the degrees at \$50.00 is \$2,450, so there is roughly \$2,950 represented in that \$5,500.

Now let me translate that amount of money to you - based on 1,900 members of this Grand Jurisdiction, that translates into \$1.55 per person, so if for some reason, you see fit to not go ahead and approve the resolutions that will be before you, you will have to consider the fact that the projected income for this coming year, in order to remain with a balanced budget is already overstated then by some \$2,950 or a \$1.55 increase in per-capita just to stay current, let alone improve on the situation.

The second, the austerity that you saw just prior to this most recent one, would require, again based on \$12,000 being developed from other than per-capita would require a two dollar additional per-capita combined with the \$19,000 from the current per-capita level, in order to make that a balanced situation, so if you go with the austerity budget, you are actually looking at a total of \$3.55 just to stay at the level that is less than it was in 1988. Obviously, the most desirable one overall is the one that allows us to grow and become truly viable and a professional operation in which we can all be proud.

The only way do that Brethren is to be prepared to pay for it. Now, Most Worshipful Grand Master, I believe that that wraps up the explanation of the three budget proposals, but before I finish, I would like to read the remainder of the report.

It is the opinion of the Finance Committee that the balance sheet as of December 31, 1988, and the statement of income and expenses for the year then ended; fairly reflect the financial status of the Grand Lodge as of year-end and the operations for the year

under review. The comparison of actual versus projected expenditures is also found to fairly portray the transactions for the year. Finally, the Projected Statement of Income and Expense for the year 1989 was also approved by this Committee, which also concluded that the records of Grand Lodge were maintained in a manner consistent with prior years.

We the members of the Finance Committee, wish to thank Most Worshipful Brother Ralph Kavorkian for the opportunity and honor to serve the Craft on this important Committee.

Furthermore, the ultimate decision as to the use and disposition of the Permanent Fund shall rest with the Grand Lodge in any future Annual Communication or at a Special Communication called for the purpose, It is the understanding of the Committee on Finance, that the Committee on Jurisprudence has a resolution prepared for this, so therefore at this time, I will only ask that the report be received for the record.

Masonic Research and Education

This year, due to a conflict of schedule, I was only able to attend the District 3 meeting held at the Masonic Temple in Anchorage. I was asked to speak and I chose to address the problem of the growing number of candidates for the three degrees of Blue Lodge that are not advancing to and completing the degree of Master Mason. The decline of membership should be of great concern to each and every Master of the fifteen Blue Lodges that make up this Grand Jurisdiction. Possibly, if each Master appointed a standing committee to follow up on each candidate when he does not progress in a reasonable length of time. Another possible solution would be for us to ease up some on the rote memory work in the posting lecture. Is it really necessary to memorize where you were escorted and how you were received?

The fraternity my Brothers is slowly but surely dying and at the 1988 Grand Lodge session held in Nome, the Grand Master's Report showed that we had 782 candidates that had not completed their work and became dues paying Master Masons. This figure is increasing every year since the formation of this Grand Jurisdiction.

This problem is one or great concern to the concordant degrees, the York Rite, the Scottish Rite, and the Shrine. All of the growth of the aforementioned bodies is 100% dependent upon the Blue Lodge, and I know that you have heard reports from various sources that the Shrine is one day going to remove the requirement that a candidate be a 32nd degree Scottish Rite or a Knight Templar in the York Rite, and that they will create Shrine Masons.

The Shrine has a great monetary need, they operate 19 crippled children hospitals and I believe 5 burns institutes. I could be called on that, all at no cost to the patient or their parents or guardians.

This operation costs a great deal of money and they have to have new per-capita paying members. They are not getting them from the concordant degrees in large enough numbers to keep up. If they should ever decide to go on their own and solicit members off the street, what do you think is going to happen to this fraternity as you and I know it today? Look in your directory of Lodges, a book that is, that every Blue Lodge has in its lobby, and you will see that 16 Grand Jurisdictions do not require a proficiency on the Master Masons degree. If the quality, is the quality of the Master Masons in those jurisdictions lower than the quality of the 782 candidates in this jurisdiction that are contributing nothing to this Grand Lodge in their time, fellowship, or per-capita tax.

Masonic Public Relations

To The Most Worshipful Grand Lodge of Free and Accepted Masons of Alaska:

Distinguished Guests, Brethren all; the goals of the Public Relations Committee this year was to make the general public aware of the local Masonic Lodges, and also of our Grand Lodge statewide visits and programs. One goal that was accomplished right after Grand Lodge in February of 1988 was to send out an article announcing the election of our new Grand Master, Ralph Kavorkian, to all the local, statewide newspapers. We picked newspapers that had Masonic Lodges near or in their city, to make the article more appropriate for each local community. We therefore included all the local Masons that were elected or appointed Grand Lodge Officers, or had been recently appointed to one of the Grand Lodge Committees. The following newspapers received an article from our Committee: The Anchorage Daily Times, Chugiak, Eagle River Star, The Cordova Times, The Fairbanks Daily News Miner, The Kodiak Daily Mirror, The Chiniak Times, The Lynn Canal News, The Nome Nugget, The Valley Sun, The Frontiersman, The Peninsula Clarion, The Seward Phoenix Log, and the Valdez Vanguard.

The Committee sent out letters announcing the Grand Masters official visits to each of the members with Alaska addressed to the following Lodges: White Pass No. 1, Anvil No. 2, Tanana No. 3, Valdez No. 4, Mt. McKinley No. 5, Seward No. 6, Matanuska No. 7, Mt. Susitna No. 8, Kodiak No. 9, Glacier No. 10, Kenai No. 11, Fairbanks No. 12, Eagle River No. 13, and Aurora No. 15. We however, did not send letters to Adak No. 14, because of its seclusion. We therefore sent out approximately 950 letters to members living in the state.

The Committee also had planned to have a speaker from our committee at each of the three district meetings. At District No. 1 meeting, there was not adequate time because of the cornerstone laying. At District No. 2, the designated speaker had the flu, but at District No. 3, we were finally able to meet our obligation.

This Committee has two recommendations for the future Grand Lodge members to discuss and solve. Number one is to have a budget for the Public Relations Committee so the Grand Master doesn't have to fund it, and secondly, the other Grand Lodge committees that need or want public exposure should work with this committee as a team

effort. Thank you Most Worshipful Brother Ralph Kavorkian for allowing us to serve on this committee for 1988,

Thank you Grand Secretary. Gentlemen, a few years back, I had the great privilege of traveling half way around the world and attending a Masonic Lodge in Jerusalem. I began to think upon the theology of such a belief and realized that men and women, human people, mankind everywhere always believe that there is a better life after this one. The reward may differ, but the reward is always better. Our Brethren whose names have been read this afternoon have departed from us. We will not see them again, but we rejoice in that they have traveled this way and that we have known them - but for a little while. I would like for all of us to bow our heads and our hearts in silent tribute to these Brethren who have labored in Craft. A moment of silent meditation, and I would like to close with a prayer or with a poem that I carry. Let us pray

Let us say that he has arrived - and not that he is gone;
May every thought of him be in that land of morn;

I think the Grand Lecturer will get more use out of that Degree Team than any other way that we could work it. Grand Master, you know I speak just like I talk. They are short! To the point!

Report of Grand Orator

Most Worshipful Grand Master, Distinguished Guests, Distinguished East and Brethren all;

I have a short one that I want to give to you from the bottom of my heart, it is in the Proceedings.

In my travels, I find that there is one subject that always comes up in conversation in Masonry. One is, the lack of interest in our new initiates - and our Brethren as well, and a lack of participation in our Lodges, and a lack of encouraging our Brothers to work in the Lodge and to participate in the activities of Masonry throughout the state. It comes to me that one of our problems seems to be that our teaching of Masonry has fallen off. Years ago, when a coach, coached a student, he usually spent about a half an hour or so discussing Masonry with him, the principles and precepts, the love, the heritage and the duties of Masonry, and about ten minutes teaching ritual. Well, that type of teaching has fell by the way because of the rushes of life. It seems like now, we give him the book, teach him to read it, and send him to the toilet and say, "when you get ready, when you can quote it, come out and we will give you another one.

We do that three times, we stand him up, say, go over and pay your dues, and we declare you a Mason. He goes home, and he sets down and he said, "I wonder what I joined?" If that's all there is to it, I can sit down and watch Dallas, and say I'm cold and have a better time, staying here with the wife. We are not teaching the principles and teachings of Masonry and the love of Masonry to our students and to our officers of the Lodge. We have got away from that. One of the Brothers went home here a while back and he said, 'he had stayed about an hour and a half over, they had got into something down at the, at the refreshment hour, and he said, and his wife said, "what was you a doing? 'Well, we was just sitting down there a talking. Lord, she said, "what was it you was a talking about? About the same thing you women talk about at your sewing circle.

She said, "I'd be ashamed." That is about the conversation we have Brothers at our coffee hours and such as this!

I think that this may be one of the things that is losing out in our Masonry. We don't instill the burning desire to perform and work in the Lodge and go out and be a Brother. One of the other things, that we can't teach it by teaching, may we should teach it by example. We should set an example of Masonry because I know that if I was to ask half the Brothers in here tonight, or today, why they joined, they would say because the example of my uncle, my dad, my cousin, my neighbor or so and so, set before me. Well, we were supposed to teach it to ourselves by those working tools. And if we applied them to this situation, we could take the plumb bob and take a thumb tack and take it into the bathroom where you dress and tie that string on that thumbtack and stick it up in the ceiling before your mirror and line yourself up to it!

Then, you should probably ask yourself some questions like, old Brother John Tate, I understand that he has been out of work for the last year, I notice that you got your garage painted, did you offer to hire him to do that? He, oh, I know that he wouldn't take charity, but he would probably have appreciated the work. Widow Jones, I know that four of you used to go a lot and visit a lot and have you and your wife had her out for dinner lately; or made an evening for her to let her know that you still cared? About Brother Tim's son, I know that he likes to fish with his dad and I know that when you were supposed to take him fishing probably a couple of times last year, didn't you, just to show him that you still belonged to the Masonic family?

When you ask yourself a bunch of these Masonic questions Brother; then look back at that string and see if you were standing as straight as you were when you put it up there, because if we don't teach by teaching and we don't teach by example, how are they going to know what we are and want to become one among us?

My father told me one time, we were standing at the edge of Cherokee National Forest, we lived right there close, he said, "son, if you walk through this and come out the other side, and have never blazed a trail, broke a twig, or disturbed anything, when you went out the other side, nobody would ever know that you were here." That is kind of the way that our life is Brothers. You know, a bishop one time on TV impressed me, when TV first came out - I know most of you will remember Bishop Sheen. I would like to leave you with this, he said "that it was better to light one candle, than it was to curse the dark." Thank you Brothers, Thank you Most Worshipful.

Report of Grand Historian

Most Worshipful Grand Master and Brethren, now this is the Historian Report for this year, and it is about a Mason that was in the Gold Rush in the days of '98 and came to Alaska and traveled back and forth over the White Pass and also the Chilkoot Pass and then eventually when the ice broke in Lake Bennett, in May of 1898, he went to Dawson and became involved in photography work of associate, well, actually a partnership with E. A. Haig the Gold Rush Photographer; and also had several gold mines claims at Dawson.

A profile of a Mason and the Klondike Gold Rush, a ton of gold - gold nuggets from shining streams, the end of the rainbow, clichés that excited the imagination and changed the lives of thousands of families. Gold from the Canadian Klondike would make a new beginning, a chance to recoup losses in the panic of 1898 to make a new stake. Gold seekers rushed north from all parts of the country to find their Eldorado. Few succeeded and many did not return. The daily activities of one of the prospectors, Per Edward Lars came to light when his notebook and papers were found by his sisters after fifty years of storage. Lars was an accomplished photographer, prospector, and dedicated Mason. He wrote a few lines and a word or two in his pocket notebook, nearly every day from 1898 to 1904. His notes and photographs provide a face in, a fascinating record of the 1898 Gold Rush to the Klondike. And, I have a picture of the crossing the pass that was taken by Lars in on a postcard that was issued shortly after the ... (not audible)

P. E. Lars was an early day photographer in Nanaimo, B.C. on Vancouver Island. He arrived there in 1892 and operated a photographic studio. In 1894 he received instructions in Masonic ideals and ritual. He attended his first Masonic meeting on December 5th, 1894. He was active in the Lodge in 1895 and 96, until his departure for Denver in May of 1896. Lars at age 35, arrived in Skagway, Alaska March 26th, 1898. He found employment with a former acquaintance, E. A. Haig. Haig was later to be recognized as one of the great photographers of the Klondike stampede and of Alaska. Three days later, he started up the steep and icy slopes of Chilkoot Pass. Here, he and Haig would photograph the historic struggles of the men and that endless chain of climbers on the icy trails to the top of Chilkoot Pass. And, in the report, I have a picture of Chilkoot Pass, and it mentions the actual angle of climb to the top of Chilkoot was 30 degrees. The pass is 3,500 feet above Dyea, a four mile climb on April 3, 1898, a disastrous avalanche came from the East side of the trail and covered about 150 yards. Over 200 persons were caught in this slide. The depth of the snow was from 20 to 50 feet, saturated with water. Thousands of volunteers rushed to the spot and frantically dug out victims. Many lives were saved through heroic efforts of the stampeeders. Approximately 63 persons perished in that avalanche and P.E. Lars was there at the time photographing pictures in fact, his diary tells about some of the people that perished. They were lying along side the trail.

In 1898, Chilkoot Pass was the most direct route to the Klondike. The distance from Dyea to Lake Bennett is 29 miles. From Lake Bennett to Dawson City, 524 miles, rafts, scows, skiffs, out-riggers, ferries, and boats of all descriptions fashioned from green

lumber traversed the 50 mile river, with a portage at Miles Canyon, Lake Lebarge, 30 Mile River, Lewis River, and the Yukon River. The Canadian government required a years supply of provisions; a ton of goods, before entering Canada. So for those who continued on, this required as many as 40 trips to the top of Chilkoot Pass, packing and caching their supplies at the top of the pass and returning for more.

Lars photographed prospectors on the Chilkoot Pass in Lake Lindeman and Lake Bennett in Canada. He completed round trips both from Chilkoot and White Pass and worked again in Haig's place developing his negatives. After two days of pleasant weather, April weather, he was back on the Chilkoot, selling photos all the way from Dyea to Lake Bennett. He then returned to Skagway in one day, via the White Pass from Lake Lindeman.

One thing that I wanted to mention, is, when, Lars was at Lake Bennett waiting for the ice to go out, he took a picture, and there is over seventy Masons on the trail, waiting for the ice to go out, and the photograph was taken by Brother Lars and a copy of this, of course, will be in the Grand Lodge archives, it shows the Brotherhood of men who came from all walks of life, who met together. He also recorded in his diary, in May of 1898, and he has a short cryptic note which most of his notes in the diary were; and he has A. F. & A. M., meeting in the church. The reason that I started this report is that I heard that there was a Masonic meeting on the trail during the days of '98. And with a little research, I was able to run down his diary and find out that they actually did have an Ancient Free and Accepted meeting on the trail while waiting for the ice to go out.

This particular photograph was taken in May 28th. The ice went out May 29th and they left for Dawson about three days later. The meeting in the church as shown by his diary, was May 25th, and I thought that it was interesting that the these early pioneers and gold seekers did and Masons were able to get together and have their meetings and have their pictures taken and recorded for history. The rest of the report goes on and tells about his finally when the ice went out, he went to Dawson, he became a partner with Haig and then later with, formed an association with Duclose (?) and this picture of the Masons, is Lars and Duclose but it was taken actually by Lars. He changed his name to Larson in 1904 and then returned south, got married, and the end of his story says that in July 1904, Lars sold his interest to the studio, to his partner Duclose The Dawson story in the little notebook ended as he left the city on March 12th, 1904. Recording the temperature of 43 degrees below zero. That doesn't seem all that cold, now.

In 1904, he changed his name to Larson and he got married and he established himself as a photographer in the gold fields of Nevada in 1905. In 1908, he was a proprietor of a hotel and general store in Allegany, Oregon, and from 1920 to his death in 1941, he was in business as P.E. Larson Grocery in San Pedro, California. A copy of his diary is on the report and will be turned in.

Charters and Dispensations

To The Most Worshipful Grand Lodge of Free and Accepted Masons of Alaska:

Most Worshipful Grand Master, to The Most Worshipful Grand Lodge of Free and Accepted Masons of Alaska:, the Brethren meeting as Masons in North Pole, Alaska, under dispensation from this Grand Lodge, were granted such dispensation without notification to, and without the knowledge of this committee. According to information received later, such dispensation was granted on 21 March 1988, thus forming North Pole Lodge, Under Dispensation. Pursuant to discussions with the Grand Secretary in mid-October 1988, and subsequently reduced to and concerned in writing by same on the date of 2 November, the Committee was informed that, and I quote, "Certification by Tanana Lodge that the North Pole Lodge Officers were proficient in the work and a recommendation that a dispensation be issued is dated February 1, 1988 based on action at the Stated Communication on January 13. The Grand Master, and the District Deputy of the Grand Master for District No. 1 also advised that the officers were proficient, the later in writing, dated January 30,1988." unquote.

Further, according to the same writing, the required written notification to Tanana and Fairbanks Lodges of the intent to issue a dispensation to work was transmitted in early March. Finally, the same writing goes on to say, "that, for the purposes of this committee, the basic requirements have been met." Subsequently, by copy of letter on 10 November 1988, from Tanana Lodge No. 3, the committee was informed that the said Lodge recommended that North Pole Lodge UD receive its Charter at the Grand Lodge session in February 1989. A similar recommendation was received from Fairbanks Lodge No. 12 on the date of 20 November. A letter report by Very Worshipful Brother John W. Casey District Deputy to Grand Master, District No. 1, on the date of 26 November further stipulates as to the proficiency of the Lodge officers, and to the effect that all necessary requirements had been met. At this now independent inquiry, and review, led the Committee on Charters and Dispensations to believe that although the North Pole situation was originally handled in a somewhat unusual manner, the necessary requirements to operate as a Masonic Lodge have now been met, and therefore recommends, that unless the Committee on Jurisprudence disagrees by finding that the pertinent provisions of the Alaska Masonic Code have not been met, the Charter be granted to North Pole Lodge UD, upon proper request for the same. Except for this matter relating to the formation of North Pole Lodge U.D, no other item was brought before this Committee.

We the members of the Committee on Charters and Dispensations wish to thank Most Worshipful Brother Kavorkian for the opportunity to serve the Craft on this assignment.

Most Worshipful Grand Master: Motion on the floor that a Charter for North Pole Lodge be granted and we nave a second, any discussion? Hearing none, all those in favor, vote by the usual sign of a Mason. Down hands, opposed - so carried.

Alaska Masonic Research Association

This is our Annual Report for the year 1988. Numerous attempts were made during the year to encourage the Brethren of constituent Lodges in this Grand Jurisdiction to join AMRA thereby, providing their membership support. These attempts included articles in the Grand Lodge Quarterly Bulletin, and personal visits to many of the Lodges by the President and District Vice-Presidents. Despite these attempts, only 39 Brethren paid dues last year. Twenty seven were renewals, 11 new members and 1 new life member, 67 belt buckles were sold during the year for a revenue gain of \$1,005.00. The main fund raising project of this past year was an auction, which we completed last night. Last night and the night before, we auctioned these items off. The original plans were for a silent or sealed bid auction, these plans were changed in September that donations were not arriving in time to be cataloged and advertised. Also, the cost of advertising the auction promised to be prohibitively high. Many items have now been received but the final result of this program was unknown at the time of this writing. I'll give you the final results in just a second.

A secondary effort was made during the year to encourage Lodges to have fund raising projects of their own. The proceeds of those projects are to be designated for the Grand Lodge Permanent Fund. It is hoped that this Permanent Fund will grow to the point that its future earnings may be used to offset some of the expenses of the Grand Lodge officers. Preliminary unofficial reports indicate that some of these individual Lodge efforts have been very successful, and as we saw just a few moments ago, they were very successful in the Lodges that had those programs. In summary, I was disappointed with the result of my efforts to build the membership of AMRA last year. It appeared that the support of AMRA by the Brethren or this jurisdiction is critically low. Unless someone has some ideas on how to improve this level of support, I recommend that we consider disbanding AMRA as a corporation and a fund raising committee be appointed by the Grand Master to continue the fund raising efforts that have previously been conducted by AMRA.

Now, as a post-script to this, I'll say that we did have a meeting here the day before yesterday and after some discussion, we decided to continue AMRA, so that was my initial recommendation which we voted not to have. Ok, now, a financial report - at the beginning of the year, we started off with \$934 our income for the year including the belt buckles and dues and a few other miscellaneous items was \$3,189.53 our debts for

the year were \$1,180.65. So our net balance in the bank at the end of the year was \$2,008.88. Ok for our AMRA auction that we just finished up last evening, we had a grand total of \$2,763.00, which I thought was very successful considering that's the first time that we have ever done that. And in another account, the Buckley C. Hazen account which is the gold pan account. The monies that have accrued in that, are a total of \$23,874.54. Grand Master, as a result of what efforts we made this year, I have a couple of checks here to turn over to the Grand Lodge - the first one in the amount of \$1,500 for the Permanent Fund account and additionally, we have a \$2,500 check to for the General Fund for the Grand Lodge to use as it sees fit. Thank you.

We did vote the other morning to continue AMRA to as the fund raising organization. Very Worshipful Brother Al White is the new President replacing me, and I would encourage all the Brethren to encourage the members of your Lodge to join AMRA and lend their support to this organization. It is one of the primary fund raising organ, agencies for this Grand Lodge, and I'd encourage everybody to give it your full support! Thank you!

Alaska Masonic Library and Museum Foundation.

The members of the Board of Trustees wish to submit the following report. The treasurers report as of January 11th, 1989 is \$2,872.71 with no outstanding debts. The Cecil Clifft Memorial Fund is \$465.00. Very Worshipful Brother Robert M. Parkins donated to start a membership longevity fund, of one dollar per year for membership in the Masonic Fraternity. This fund now totals \$637.00. Both of those funds are ready for further contributions if needed. All requests for interviews with prospective contributors have been filled in a timely fashion and we will continue to answer all inquiries as best we can. Brother Wendal H. Kuecker still kindly offers his expertise to the Board of Trustees. The Foundation received from Most Worshipful Roy Foss, a complete set of bound proceedings of the Grand Lodge of Washington, dating from 1858 through 1986. They are safely stored in the building of Kenai Lodge No. 11 until such a time as our Library has a place for them to be stored properly. The Internal Revenue Service has closed their investigative files on the Foundation. And have now given the Foundation a permanent 501-C Tax Exempt Status, meaning, real, for-sure, non-profit organization and Brethren, that is through the hard work again of that Past Grand Master, Jim Williams and that Past Grand Master, Gunnar Flygenring, they worked endlessly to share that report!

The Alaska Masonic Library and Museum Foundation is getting more and more on a firm foundation so to speak with the scheduled

meetings being held in Anchorage at the Al Aska Shrine Temple Mosque. The next Annual Meeting is scheduled for March the 28th, 1989 and we encourage you to attend with your ideas, your interests, and your willingness to serve on this board of trustees.

RW James M. Shillingburg, Grand Lodge of Oregon

Most Worshipful Grand Master, on behalf of my Grand Master, Quintin Estell, he sends his greetings and his regrets that he could not be here, however, he being a working man had to schedule his District meetings at this time of the year and just could not get away. Also, I was requested by our Grand Marshal Brother Al Carter to send his greetings as well as Vern Garvin. Vern wanted to be here also, it just so happened that the Grand Masters District Meeting was in his area. So Vern felt that he should stay there. It is a pleasure to be here, I feel like I know most of you.

You know when I first told my office staff that I was coming up here, they all thought I was crazy. 60 degrees below zero. I talked to them yesterday on the phone, and they would like to trade places with me. All of a sudden it is not so bad up here. Our Grand Master, Quintin Estell, is an attorney and as your head of your Jurisprudence Committee was speaking, I heard someone comment that he was an attorney, and I like attorneys, there is one thing that seems to be prevalent with all attorneys, they have very good information. And to cite an example of this, maybe some of you have heard this but, there was two fellas out in a hot air balloon, and they were traveling, and all of a sudden a cloud cover came in. And of course you know if you are up there, you don't have all the instruments that we have in airplanes. And they were lost almost instantly. So they went along and all of a sudden, there was a little bit clearing and the clouds separated and they went over and there was a man standing down there, and one of the fellows from the balloon said, "Hey down there, can you tell us where we at?" And he said, you are exactly 75 feet above the ground, right above me. And the clouds came back, and one fellow in the hot air balloon said to the other, "Well, that attorney sure didn't help us any" and the fellow said well how do you know he was an attorney? Well, because, what he told us was absolutely correct, but the information was absolutely worthless.

In Oregon, we are doing several things down there, and I know that we are short on time, so I am going to be quick. There is one thing that we are doing that I would like to leave with you. We have a Masonic and Eastern Star Home in Oregon, and it has its limitations, we were aware of that. But we are in the process right now, we are under construction, on a five million dollar apartment complex that will be designed for a Masonic family. It has nothing to do with turning over your assets such as most of the Masonic Homes are. This is designed for Masons and their families when they retire. One and two bedroom units. The requirement is that you must have Masonic affiliation, and that you must be fifty five years of age or older, and we had to put that age limit on it to qualify for the 1988 housing law. Each of the units have emergency call systems, the entire complex is secure and there is a nurse on duty 24 hours a day. We have a Jacuzzi room, we have exercise rooms, laundry facilities, we will provide maid service, we do your linens, change your beds, all utilities are included even your cable TV. Three meals a day in a restaurant atmosphere. Each of the units also has their own little kitchens, patios, balconies, air conditioning, and the reason that I am taking the time to tell this is because unlike anything that I am aware of that has ever been done in jurisdictions is that this is open to all Masons. Not just Oregon Masons - California, Idaho, .Alaska, wherever. I bring this to you that if any of you are contemplating moving to south, where it is colder than it is here. I would be happy to send you any information.

I also was pleased to hear the report on your Publicity Committee, one thing that we also are doing in Oregon this year, we budgeted \$25,000 and we are putting on radio spots clear across the state, designed 30 seconds in nature or less, designed just to tell people what we are and it is something that is going to be ten years worth of work and we hope to be able to put \$25,000 a year for the next ten years.

Most Worshipful Grand Master, I appreciate the opportunity to speak before this crowd, I would like to thank you for all the hospitalities and I hope that we will, well, I know that I will see you next month in Ashland, and I hope to see you down in Oregon as many times as you want to come. Thank you.

South state of Alabama. It was about 72 degrees when Brother Hambrick and I left there a few days ago. I have had about a 103 degrees change of temperature I think, sometime during the night last night, which is chilling. I don't know if I have ever seen it that cold and don't know if I want to see it that cold again. I stuck my head out this morning, and believe me, it almost took my breath, it is something that is unusual for us.

It is indeed an honor to come here today, and be in this session and to address this body because it is a real honor because I am the first sitting Grand Master of the State of Alabama to come to the Grand Lodge session of Alaska, and I'll always hold that honor. It is an honor because Brother Ralph has been coming to our Grand Lodge sessions for several years and I promised him that when I went into the Grand Lodge line a few years ago that if I was still financially able and well that I would be at his Grand Lodge session, and so Brother Hambrick and I set out a few days ago and we got side tracked in Salt Lake City for a day but we watched it snow and I have never seen it snow so much in my life, about 12 inches in one night. And that is unusual for us.

I was just in Orlando, Florida this past Monday, and it was 82 degrees. I was in San Juan, Puerto Rico just a few days before that and it was 84 degrees there and so I have came through some quite extremes getting here. I was a little amused at our officers that were elected when they came to the microphone and accepted their election in the offices. I know how they feel, that is a little awkward position, maybe we could do that differently some time, I know how awkward I felt. You sort of feel like the bridegroom on his wedding night, you know what you are supposed to do, but you just don't know where to start. We have had one public ceremony already this year. I laid the cornerstone to a public building in Dale County, Alabama, down at Ozark. I had to learn the cornerstone ceremony, memorize all the verbiage and I didn't have any problem with that.
