RECOMMENDATIONS

1. This year I made some changes in the Districts. District No. 3 had eight Lodges. With the approval of Anvil Lodge No. 2 and Valdez Lodge No. 4, I moved Valdez Lodge No. 4 into District No. 1 and made a new District No. 5 where I put Anvil Lodge No. 2, Matanuska Lodge No. 7, Eagle River Lodge No. 13 and Iditarod Lodge No. 20 which evened up all the Districts. This re-districting needs approval of Grand Lodge.

2. I recommend that we continue the dialogue with Prince Hall Masonry.

3. I recommend continuing the Lodge-Range Planning Committee and, by resolution, that we make it a Standing Committee of this Grand Lodge.

4. I recommend raising the Per Capita by \$1.50. \$.75 to go for the Grand Lodge Bulletin and \$.75 to the Grand Secretary for salary increase.

DECISIONS

In late August, I received a request for an Appeal from one of the brothers of Matanuska Lodge No. 7. The request was out of time. I researched the old records to be sure of making the proper decision. I agreed with the Lodge Verdict and denied the request.

ANNUAL REPORT OF THE GRAND SECRETARY

To the Most Worshipful Grand Lodge of Free and Accepted Masons of Alaska

The following report is submitted pursuant to Section 3.05 of the Alaska Masonic Code.

Time marches on and it is again time for my annual report on the activity of the Grand Lodge Office and the condition of the Constituent Lodges in Alaska. Again, my thanks go to the Secretaries of the Constituent Lodges. Although there are problems at times, I offer my appreciation for your hard work and dedication.

I am still having a few problems with receiving the Lodge paperwork in a timely manner. As required in Section 15.08 of the Alaska Masonic Code, I must report that Seward Lodge No. 6 and Kodiak Lodge No. 9 did not file their paperwork by the February 1st deadline and both of those Lodges were charged the allowed late penalty. Seward Lodge No. 6's Reports were filed on March 11th. I finally closed the records of Kodiak Lodge No. 9 on March 20th to stop the fine. I have instructed the Lodge to file "No Change" Reports for April-December of 1996. By doing this, I have some numbers to deal with for projected income. On a positive note, I think I had fewer problems with the numbers on the Monthly Reports than I have ever had. Again, thank you to the hard work that many of the Secretaries are doing.

I know that some of you object to the "new" format for the Status of Lodges but the old format will still not fit on one page. I think I can go back to the old format next year as we will no longer show Adak Lodge as part of this Jurisdiction. Our loss was due to a number of Adak Members asking for dimits when Adak Lodge No. 14 closed.

The major accomplishment of the year was the final updating and reformatting of the Alaska Masonic Code. The original Code of 1988 was prepared on a very old version of WordStar. I had a Conversion Program to convert the document to Microsoft Word but that Conversion Program self-destructed a couple of years ago and it has taken me this long to complete the updating. The new Codes are now ready and are available at this Annual Communication. There were no changes to the Code except in formatting and page layout.

I know I say this every year but the Warden's Charge Weekend continues to be one of the best programs this Jurisdiction has to offer. Congratulations to our Warden's Charge Committee for another year of hard work. This program provides valuable material to the Wardens and Senior Deacons in the management of their Lodges.

The Financial Section is self-explanatory. Two Lodges have transferred their Life Membership Fund to the Grand Lodge of Alaska. The Life Membership Fund listed in the Financial Section is made up of money from Iditarod Lodge No. 20 (which included Adak Lodge No. 14's money which was transferred to Iditarod Lodge No. 20 before Adak closed) and Kenai Lodge No. 11. This year the Grand Lodge was able to pay a 7.5% return less the .5% administration fee. The Grand Master's Calendar program netted the Permanent Fund \$4564.15 after expenses as of 12/31/96. The 365 Club had deposits of \$6,642.30 which included a \$3,900.00 contribution from AMRA.

I would like to close this report, as always, by saying thank you to the people that I count myself fortunate to work with each year. The Grand Lodge Line Officers are a very supportive group. Yes, Grand Master, I will miss you. RW Brother Steve Lee has done an outstanding job as Grand Treasurer in his first year and it is a real pleasure to be able to work with him. Last but not least, I say thank you to the two best people in my life, my wife Linda and my daughter Katie. To both of them, thank you for your help and support. Brothers, this concludes my Annual Report. Thank you for the opportunity to serve you and Masonry in Alaska.

REPORT OF THE FRATERNAL RELATIONS COMMITTEE

1st Report

(Transcribed from tape recordings of the Grand Lodge Communications)

To The Most Worshipful Grand Lodge of Free and Accepted Masons of Alaska

The first report of the Fraternal Relations Committee is a brief summary of actions reported by the Commission on Information for Recognition of the Conference of the Grand Masters of Masons in North America at their annual meeting in Tulsa, Oklahoma in February 1977 (1997?).

Andorra.

The Commission had received requests for recognition from the Gran Logia Regulaire del Principat d'Andorra. Andorra is a small state in the Pyrenees Mountains between France and Spain. There are at least ten lodges in this state chartered by at least three different Grand Lodges. Seven of the constituent lodges formed the new Grand Lodge, three others were excluded. While the Commission is sympathetic to nationalistic desire to form a Grand Lodge in Andorra, the Commission is of the opinion that the Gran Logia Regulaire del Principat d'Andorra does not meet the standards of the Commission in that there are concerns about the legitimacy of origin and that it does not share territorial jurisdiction by mutual consent or treaty.

Benin.

The Grande Loge du Benin was consecrated on January 14th, 1995 in Cotonou by the Grande Loge Nationale of France. The ten constituent lodges were all chartered by the Grande Loge Nationale of France with the oldest lodge having been chartered in 1973. Since this Grand Lodge was consecrated by the GNLF (Grande Loge of France) there can be no question of its legitimacy of origin and it has furnished the Commission with full information about its lodges and constitutions and laws. It meets fully the standards of the Commission adopted by this conference. The Commission is of the opinion that it is entitled to recognition as a regular Grand Lodge. It has been recognized by the United Grand Lodge of England, the GNLF, and other regular Grand Lodges. We have not had a request from them, that is why we need no vote on it.

Madagascar

The Grand Lodge of Madagascar was consecrated by the GNLF on March 6th, 1996 with three Blue Lodges. Two more lodges were set to work in January 1997. This Grand Lodge has furnished full information to the Commission with references to its regularities showing that it meets the standards for recognition adopted by the Conference of Grand Masters.

Portugal.

The Grand Lodge of Portugal continues its regularity with Brother Louis Nandim di Carvalho as Grand Master. A current address was received for the Grand Lodge Office and the Grand Master both in Lisbon, Portugal.

Romania The Commission last year reported on The National Grand Lodge of Romania headed by Grand Master Frientu (spelling ?) which we considered the regular Grand Lodge. There has existed for some time another Grand Lodge with the same name headed by Vladimir Voanta (spelling ?) as Grand Master. Through the efforts of a Romanian Mason in France these two Grand Lodges were merged on May 26th 1996 in Bucharest making Fientu the Grand Master and Vladimir Voanta Grand Master Honor Advitim (spelling ?). The Commission is aware of a United Grand Lodge of Romania which was organized on March 9th 1996 in Alb Eva, Romania with Dr. Titus Nicorra (spelling ?) said to be the Grand Master. The Commission considers this to be an irregular Grand Lodge.

Russia

This Grand Lodge has made excellent progress under the leadership of its Grand Master Georgia Dergachev in spite of the still chaotic political and economic situation in Russia. The commission reported in 1996 that under the sponsorship of the Grande Lodge National of France there was no question of the legitimate origin. A new lodge was chartered in Moscow by the Grand Lodge Russia in June of 1996 and will work in English. There are now five constituent lodges under this Grand Lodge, three in Moscow, one in Petersburg, one in Voronezh and this Grand Lodge has been recognized by four Grand Lodges in the United States, five in Canada ... (break in tape)...

... (break in tape)... not entitled to recognition, because it does not meet the standard for recognition.

This Grand Lodge has been recognized by four Grand Lodges in the United States, five in Canada, six in Europe, and a number of regular Grand Lodges elsewhere in the world. The Commission on Recognition of the Grand Master's Conference encourages other Grand Lodges to also grant recognition to the Grand Lodge of Russia.

4th Report

We have received a request for limited recognition from the Most Worshipful Prince Hall Grand Lodge of Free and Accepted Masons of Alaska and its Jurisdiction Incorporated. The Most Worshipful Prince Hall Grand Lodge of Alaska was organized on September 6th, 1969 and constituted by the Most Worshipful Prince Hall Grand Lodge of Oklahoma. It currently consists of the following constituent lodges. Alpha Lodge No. 1 at Elmendorf Air Force Base, Mt. McKinley Lodge No. 2 in Anchorage, Midnight Sun Lodge No. 3 in Fairbanks, Summit Lodge No. 6 at Fort Richardson, and Arctic Lodge No. 7 in North Pole.

The Most Worshipful Prince Hall Grand Lodge traces its Masonic lineage back to the Most Worshipful Prince Hall Grand Lodge of Massachusetts and Africa Lodge No. 459 who was granted a warrant from the Premier Grand Lodge of England on September 29th, 1784. On November 21st, 1994 the United Grand Lodge of England granted recognition to the Most Worshipful Prince Hall Grand Lodge of Massachusetts

It further stated that action should not be a general precedence of all Prince Hall Grand Lodges, but that each one should be considered on its own merits. This Committee has investigated Most Worshipful Prince Hall Grand Lodge of Alaska and finds that it meets the standards of recognition as set forth in the Alaska Masonic Code and by the Grand Master's Conference of North America.

If this report is adopted, it will take effect by decree of the Grand Master only after such time as the Most Worshipful Prince Hall Grand Lodge of Alaska has adopted similarly legislation and our constitution has been amended to allow for shared territorial jurisdiction by our two Grand Lodges by mutual consent.

Carryover Resolution 96-4

To Amend Section 1.05 of the Alaska Masonic Code

To the Most Worshipful Grand Lodge of Free and Accepted Masons of Alaska:

STATEMENT OF PURPOSE: To reinstate the original time/date of the Annual Communication.

RESOLUTION:

WHEREAS, the change of the Annual Communication date to April has resulted in fewer attendees from other Jurisdictions; and,

WHEREAS, the earlier February date occurs after the usual mid-winter vacation time and prior to the startup of many of the Alaskan industries and does not conflict with the Communications of the other Grand Lodges; and,

WHEREAS, the present April date also comes after the fishing season has opened, thus preventing those in that industry from attending; and,

WHEREAS, the present date is at a time when the Scottish and York Rites are busy with their Annual Communications in other States, as well as in Alaska - thus drawing potential attendees from our Annual Communication; and,

WHEREAS, better hotel and airline rates are usually obtainable in February rather than in April when the tourist season has already started in many places; and,

WHEREAS, visitors from the South and elsewhere want the “Alaskan winter experience” when they come to Alaska rather than seeing the dirty snow melting and having to “navigate” our muddy and slushy roads; and,

WHEREAS, Junior Grand Wardens of other Jurisdictions, who desire to make plans to attend our Grand Lodge when they are Grand Masters, can hardly find a calendar which will tell them four (4) years in advance when Easter will occur during that particular year so they may know the exact date; and,

WHEREAS, because the Conference of Grand Masters meeting comes in late February, it is of no particular use to a Grand Master who is nearly out of office then, but offers great benefit to him if he has been installed just days prior to that meeting; and,

WHEREAS, a Deputy Grand Master “carries little or no weight” and is “paid little or no attention” at the Conference of Grand Masters;

NOW, THEREFORE, BE IT RESOLVED, that the first three sentences of Section 1.05 of the Alaska Masonic Code which now reads:

Communications. Grand Lodge meets annually on the first Thursday in April. In years when Maundy Thursday falls on the first Thursday in April, Grand Lodge will meet on the second Thursday in April. This change will become effective with the 1994 Annual Communication.

be reduced to two sentences and amended to read:

Communications. Grand Lodge meets annually on the first Thursday in **February.** This change will become effective with the **2000 Annual Communication.**

RESOLUTION:

WHEREAS, most Lodges have their annual election of officers on the Stated Communication in November, however some Lodges can also choose the Stated Communication in December per Alaska Code; and,

WHEREAS, Lodges: White Pass No. 1, Kodiak No. 9, Fairbanks No. 12, North Pole No. 16, Tongass No. 19, and Iditarod No. 20 all have their Stated Communication on the third or fourth week of the month, therefore, they are excluded to have their election of officers at their Stated Communication in December if they choose, except by a request for a Dispensation from the Grand Master; and,

WHEREAS, this proposed Resolution will put all Lodges on an equal status;

NOW, THEREFORE BE IT RESOLVED, that Section 16.05.01 Bylaw of the Alaska Masonic Code which now reads:

ELECTION, WHEN TO BE HELD.

1. The Master, Senior Warden, Junior Warden, Treasurer, and Secretary are chosen annually by secret vote. Election is by a majority of votes by members present and voting. The election must be at a Stated Communication of the Lodge held between November 1 and December 15. Officers are installed at a Special or Stated Communication as soon thereafter as possible.

be amended to read:

ELECTION, WHEN TO BE HELD.

1. The Master, Senior Warden, Junior Warden, Treasurer, and Secretary are chosen annually by secret vote. Election is by a majority of votes by members present and voting. The election must be at a Stated Communication of the Lodge held between November 1 and **December 31**. Officers are installed at a Special or Stated Communication as soon thereafter as possible.

STATEMENT OF PURPOSE: To be more consistent and considerate in our Membership Recognition.

RESOLUTION:

WHEREAS, the majority of Master Masons may be a member long enough to have recognition as a member for twenty-five years; and,

WHEREAS, very few Master Masons achieve recognition as a fifty-year member; and,

WHEREAS, many Master Masons are members for forty years or more, but never as a fifty year Master Mason; and,

WHEREAS, this Resolution would give recognition to all Master Masons with over forty years as members and for each five year increment thereafter; and,

NOW, THEREFORE, BE IT RESOLVED, that Section 17.17 of the Alaska Masonic Code which now reads:

Section 17.17 Bylaw

TWENTY-FIVE YEAR MEMBERSHIP RECOGNITION. A Master Mason belonging in this Grand Jurisdiction who has maintained membership in some Symbolic Lodge for at least twenty-five years under the provisions of Section 17.18 may be presented by his Lodge with a certificate and button of uniform design as prescribed the Grand Master and the Grand Secretary.

be amended to read:

Section 17.17 Bylaw

TWENTY-FIVE YEAR MEMBERSHIP RECOGNITION. A Master Mason belonging in this Grand Jurisdiction who has maintained membership in some Symbolic Lodge for at least twenty-five years under the provisions of Section 17.18 may be presented by his Lodge with a suitable card, or certificate and lapel emblem of uniform design as prescribed by the Grand Master and the Grand Secretary.

is the duty of the last presiding officer, the Secretary, and the Treasurer to surrender the properties without delay to the Grand Secretary. In case of real property, the proper officers shall have the title conveyed to the Grand Lodge.

Jurisprudence Committee explanation of Resolution 97-6

The Committee has determined that the intent of this Resolution is already covered in the Code, therefore it would add unnecessary or redundant wording to this Section.

The statements of fact are as follows:

(1) Section 12.05 Bylaw LOTTERIES

The conduct of raffles, bingo and other lotteries to the extent authorized by civil law are permitted, providing that all organizations conducting same fully comply with all state and local laws, rules and regulations.

A. Lotteries, raffles or gaming has basically the same meaning: “a game of chance in which numbered tickets are bought and prizes given to numbers drawn by lot.”

B. The gaming permit holder must comply with all state and local laws (in this case by the State as it issues the permit).

(2).Section 21.07 Constitution PROPERTY OF DEMISED LODGE (3rd line)
...and other property of the Lodge vest in and belong to the Grand Lodge subject to the legal rights of creditors of the demised lodge.

A. "Creditor" is the crucial word as creditor "includes everyone having right to require the performance of any legal obligation, contract or guaranty." In this instance, the State is the "creditor" as it issued the Gaming Permit and would also apply to the Beneficiary or Charity named in the permit as required by State Law.

(3) Section 9.01.3 Constitution REVENUE SOURCES

3. From the funds, dues, and proceeds of the property of dissolved Lodges within its Jurisdiction; subject to all legal and equitable rights of creditors of such dissolved Lodges in and to such properties.

A. Again the word "creditor" is used; therefore the State would be a creditor if a Lodge has a Gaming Permit from the State and said Lodge is dissolved.

Resolution 97-6 was ruled by Jurisprudence as being out of order. Below following is Tom Houser's information on Resolution 97-6.

Brothers, those of you who have your Blue Book, the explanation to whole problem is on page 31 of the Blue Book and that is the letter written by Jurisprudence chaired by VW Cliff Darnell back to me as the writer of the Resolution and is contained here

It states in part that the Committee has determined that the intent of the Resolution is already covered in the Code. Therefore, this would add no more than unnecessary or redundant wording to this section. The rub lay that, very briefly, Grand Master, if you will, to apply for a raffle permit in the State of Alaska, all moneys reference that permit must be held in a separate account that can be audited at any time by the State of Alaska. The State of Alaska requires when you apply for the permit, you provide a copy of the Bylaws of your organization stating in your Bylaws where all of the money in this account shall go in the event of the demise of your organization. Now, there's the rub and it must be in a pre-named charity. The charity must be listed in your Bylaws.

The problem being that Section 21.06 Constitution Property of Demised Lodge within our Grand Lodge if a lodge goes defunct all the property owned by that lodge must then go to the Grand Lodge with exception that of proper creditors and whatever. Then the current Jurisprudence Committee ruled that the key word is that particular thing is "creditor." Creditor would include anyone having a right to acquire the performance of legal obligations, etc. This obligation of sending this money to this charity would be a legal obligation of the lodge as required by the State of Alaska. So, therefore after that money were disposed of, as per the Bylaws to this charity, the remainder of all properties of the lodge would go to the Grand Lodge. So, therefore, as the Code is written now there is no problem with getting the permit.

VW Cliff asked if I would like to withdraw this Resolution and I said no, because I wanted their interpretation of the present Code written into the record. There, then a lodge could apply for and receive a gaming or raffle permit. Because, if this is not written into the record and the opinion of the Jurisprudence Committee next year is not the same then that particular lodge would be in violation of the Code.

I did, approximately three years ago, submit the Bylaws of our lodge to have this included so that we could get a raffle permit. I was told then by the Jurisprudence Committee I couldn't do it. So, what we are dealing with here is an interpretation by the Jurisprudence Committee of our Alaska Masonic Code.

I hope and pray, Grand Master that I haven't confused the issue

A trial was conducted on 18 December 1996 by Fairbanks Lodge No. 12 F. & A. M. It is the recommendations of this Committee that the judgment of the Lodge be changed to a guilty verdict. We recommend a sentence of thirty days suspension.

Report of Grand Orator

(Transcribed from tape recordings of the Grand Lodge Communications)

Most Worshipful Grand Master, Grand Lodge Officers, Distinguished Guests, Brethren all, at the will and pleasure of the Grand Master this year the Grand Orator's message was to be directed to the Alaska Masonic Code and the Alaska Monitor and Freemasons Guide. Faced with this challenge I consulted the Code book and Monitor looking for inspirations to bring a meaningful and educational message to you Brethren. After perusing them both, I thought the tried and true journalistic approach to relating information by employing the five "W's," Who, What, Where, When, and Why might be appropriate to this discussion.

The WHO is conveniently covered by the blanket endorsement of including all Masons in Alaska and in some respects all Masons everywhere. By this I mean the actions of Masons are controlled, hopefully, in some measure by our basic beliefs and obligations taken by each and everyone of us while traveling that sometimes rough and rocky road becoming a Master Mason. Even our forefathers adhered to a Masonic code that governed their thoughts and actions in the course of making our great nation the place that it is today. The Who is you , me, them, and us collectively.

The WHAT is not so easily addressed. The Alaska Masonic Code and the Alaska Monitor parallel the Holy Bible in some respects. For as the Holy Bible is the rule and guide of our faith, the Code and Monitor are the rule and guide of our many actions. As we review these two great instruments of policy and procedure, it becomes clearly evident that in carrying out the directions of actions and ritual, lecture, policies, and so forth there exists pit falls in the form of that controversial word “interpretation.”

As soon as one is able to read the written word they become a victim of interpretation. One has to decide what did the passage state, what did it really mean, and what did the author intend. During my year as Master I struggled with interpretation of Alaska Masonic Code and the Alaska Monitor in carrying out the duties of my office. The suggestions and guidelines in the Lodge Officers Handbooks seem fairly straight forward to me. The Alaska Monitor seemed to follow a logical path to preparing the candidate to be made a Mason, to raising him to the sublime degree of a Master Mason. If there was a question of a time between degrees, the fees for affiliations, the sequence for events, ritual, or other questions about policy and procedure, a quick review of the Code or Monitor would seem to furnish the answer. But, as a young Mason being Raised in June of 1987, I obviously did not understand the interpretation.

I don't have to tell any of you active Masons here today about these situations. You have faced this same dilemma in some form or other regardless of your station or place in Masonry today. From observing as a sideliner at lodge meetings to serving in an official capacities in your lodge or Grand Lodge, there are instances where interpretation has delayed meetings, cause conflict in thought and action, and in some case resulted in emotional outbursts creating anything but peace and harmony.

Therefore, my Brothers I urge you to consult the Alaska Masonic Code and the Alaska Monitor and Freemasons Guide in matters concerning your Masonic activities in Alaska. Even more important is that once the guideline is confirmed, everyone abide by it and proceed with the activity. If you do not agree with the Code or Monitor then follow the prescribed path of changing the item, that is to bring a Resolution before the Grand Lodge body for discussion and vote.

WHERE seems so simple. Why not just say everywhere and be done with it? That is not acceptable because it overlooks some points to consider. I think we need to be reminded that often times we are the first impression of a Mason that someone observes; that our actions, no matter how well grounded in Masonic Code or Monitor can be presented in such a way that others are not offended; that one of the very reasons we maybe losing

members is because we lack peace and harmony or that we constantly disagree with lodge procedure or policy.

Do we practice what we preach? In living our daily lives, are we known and respected as Masons because of our actions or in spite of them? The WHERE my brothers applies to us as individuals where from the first charge we received we are reminded that as an individual you are charged to practice the domestic and public virtues and be faithful to the trust committed to your care among any other lines we as Masons are expected to follow. WHERE means wherever our thoughts and actions maybe observed by and influence others.

WHEN should we be consulting the Alaska Masonic Code and Alaska Monitor and Freemasons Guide when there is a question about anything being done in Alaska which seemed to be the logical answer. That is the reason they are deemed the guidelines, rules and policy for ritual, policies and procedures for Masons in Alaska. I'm not about to enter upon a dissertation by chapter, verse or section number in the Code book or degree, page number of the Monitor because that is of the individual to become familiar with and follow these rules and guides.

But, I would like to point out that if you have an opinion or wisdom to impart regarding an action being taken in your lodge meeting, committee meeting, or even a Grand Lodge communication like the one now in session, you're obligated by your vows as a Master Mason to express the same in such manner as to not be disruptive, argumentative, or in conflict with the Worshipful Master or Grand Master who is control of the meeting by virtue of his office and Masonic Code.

That does not mean that we can not agree to disagree and discuss it at a later time. That option should remain open regardless of the circumstance. When to consult the Code and Monitor should be remembered by those leadership roles of this great fraternity of ours. They may not provide all the answers or the answers you want to hear but they must be followed as the rule and guide of our actions as Masons in Alaska.

WHY should be considered about rules and guidelines in Masonry? Why don't we just follow the rules of society and be good old boys and everything will turn out fine? I think the reason is interpretation. With the firmly established written Masonic Code and Monitor we have the basis for standard work and rules to govern ourselves by even though we still may disagree with some aspects of their content. They may be used for conflict resolution, standardization of work in all lodges with this jurisdiction providing rules for conducting business within lodges and temple holding companies, making loans, setting fee schedules, providing rules for revenue sources, granting authority for lodges and forming new lodges, outlining funeral services and cornerstone laying ceremonies, and on and on. All one has to do is pick up a copy of the Code book or Monitor and read the table of contents or index to see what is covered concerning our actions as Masons. Knowing the existence of these two instruments of policy and procedure and following them are two of the greatest challenges facing Masons in Alaska today.

Illustrious Walter B. Bonner, Potentate Al Aska Shrine Temple

Worshipful Grand Master, Distinguished Visitors, Brothers I appreciate the opportunity to be able to talk to you for a few moments this afternoon about the Shrine, because the Shrine of North America is 125 years old this year. Our hospitals are 75 years old. The hospitals themselves are all new because in June we will have finished a rehabilitation program which will have rehabbed all of our 22 hospitals and actually replaced several of them so that we will have state-of-the-art facilities throughout the United States and Canada to provide treatment for our kids.

Another unique thing about 1997 is our Imperial Potentate and the Imperial Divan is asking us to emphasize in 1997, not the fact that we're out looking for money to continue to make our system operate but that we're looking for kids to bring into the program to

ensure all these hospitals throughout the United States and Canada are filled and operating to their capacity. We've got a new hospital emphasis coming up on line down in Sacramento which will have, I believe, like ninety beds and we need to ensure that we not fill it and keep it filled all the time because we're able to do things now in an outpatient basis that ten years ago, fifteen years ago required extensive hospital stays. So, we're bringing them in, treating them, and sending them home.

I ask each and everyone of you if you are a Shriner or a Mason that has not yet decided to walk the sands and become a Shriner, to take each and every opportunity that you have to tell the story of our hospitals and when you see a kid who has an affliction or a problem that we can treat, even if you're not sure that we can treat them, please get them enrolled in our program so that we can examine them at an outreach clinic or take them to hospital and get them enrolled, because this is what we're all about. We're now in the Shrine, we've shrunk down to about 586,000 Shriners, but we've still got twenty-two state-of-the-art hospitals staffed with some of the best doctors and nurses on the face of this globe and we need all the help that we can get to bring kids in.

Another thing that we're hoping to do in this 125th anniversary is to do something, maybe to reverse the trend on membership. We've got jurisdictions outside in the "Lower 48" which are trying some really new and innovative things to bring new people into Masonry, new people into the Rites, and new people into the Shrine. In fact I was talking to one of our visitors from Virginia, either last night or the night before last and he was telling me that in a couple of the jurisdictions with which he is acquainted in two weekends they made 1500 new Masons, Scottish Rite members, and Shriners. That's a mind-boggling figure to me when I realize our entire Shrine Temple has only a thousand members right now. We could double Al Aska Shrine temple if we had two weekends like that. I'm not advocating that every jurisdiction is going to find that kind of system the one that works for them, but I know that in every jurisdiction we can find something that will work for us. So, I would urge you to all look at things not a tradition bound concept that we've always done it that way so we can never change because Brothers we've got to be somewhat adaptable to change if we are going to be a viable and growing organization in the Shrine, in the Rites, and in the Blue Lodges in the United States, actually in the world today.

I hope that many of you, especially those of you from Alaska will be involved in the anniversary party which we are going to put on in Anchorage on July 12th of this year to commemorate the 75th anniversary of the Shrine hospital system. The Portland hospital is going to do the same type of celebration at Portland and invite as many of their graduates back as they can and we here in Alaska, while we are much younger than 75 will have to bring as many of our Alaskan Shrine kids back even if those Alaskan kids are forty, forty-five years old. We want to bring them back and renew old acquaintances because it's the kind of things that we need to do to generate knowledge within the public of what we do. We've got to get out and get things so that they know what we're about.

Most Worshipful Chuck Gregg, who is sitting here in this audience today is our public relations chairman for Al Aska Shrine Temple and he's working real hard to get our

message out in front of the public in Alaska. I would urge you in your Lodges throughout the State to take every opportunity that you have to feed things into Most Worshipful Chuck so that he can get things in our Fez Magazine. He can get things into the local newspaper even was able to persuade one of the our local TV stations in Anchorage the other day to give Ray Gallant and me about 15 minutes of prime air time so that we could talk about the Shrine story. So, if he can do it without the help, just think of what he could accomplish with all of you and your members in the Lodges throughout the State of Alaska.

I appreciate the fact that I have been given the opportunity to serve as Potentate of Al Aska Shrine Temple in 1997. I appreciate the fact that the Grand Master has asked me to come and then he's allowed me to stand here and talk to you today, because I've been a Mason for several years now. In fact the day I was installed gave me my 25th anniversary pin, 25 year Mason pin. It made me feel really good but this is the first time that I've had an opportunity to stand and talk to you at Grand Lodge other than one time, I believe it was Most Worshipful Frank Erie gave me the gavel to call you to attention once after a lunch session. And, that was kind of a thrill in itself, but this will really get you moving when you can stand here and look out at all these years of Masonry all this knowledge and talent and be able to talk to us.

So, for those of you who haven't stood here on the podium yet, I urge you to take every step you can to get involved in your Grand Lodge and rotate through the various positions and make yourself available with the elected line and maybe one day you would be sitting here and get the privilege of showing the total lack of emotion that Most Worshipful Grand Master Lloyd Triggs did this morning. I've never seen a man who had a tighter grip and I know that he would agree with me that has to be the ultimate in your Masonic career. So, I would urge you to get out and do those things, find the time, but as the man who is most interested in the Shrine in the State of Alaska, I want you to do something for me, let's find some kids. We've got 369 Alaskan kids currently enrolled in the program and I'd like to have 469 or 569 kids if we have that many that need treatment.

RW Edward O. Weisser, Grand Master of Pennsylvania

(break in tape) ... Grand Lodge and its our privilege to be here.

We’re here for two purposes. Number one is because we wanted to come to your Grand Lodge. I’ve always loved Alaska. I even said in my high school book that my desire was

to join the Navy and go to Alaska. I didn't join the Navy but I did get to Alaska. I was here about ten years ago and as Grand Master in Pennsylvania I decided that I would like to have a cruise for our Grand Lodge to Alaska. This summer on the third of August we're leaving with approximately 400 Masons and wives and coming here for a visit. We're anxious to do that and we're looking forward to do it. We're going to be landing in Anchorage probably on the tenth of August and I've already informed your supposedly in-coming Grand Master of our program and he will let you know about that in due time.

I'd just like to say just a couple of things. Our Grand Lodge is the largest Grand Lodge in the United States. We just passed Ohio in membership now and we're proud about that. I would think that this is the smallest Grand Lodge in the United States. I'm not quite sure if Delaware is smaller, but I don't believe so. But, I say to you that from the 160,000 Masons we have in Pennsylvania to the 2,000 some I saw in your report, I find one thing interesting Brethren that where I have 160,000 Masons or where we have less than 3,000 the friendship and the comradery is amongst us all and that is what Freemasonry is all about.

I see you just suffered through a situation I suffered through as Grand Master about four weeks ago, that had a man challenge the Grand Lodge on the floor and then cursed the Grand Lodge and cursed Masonry and I suspended him for non-Masonic conduct. Brethren I say to you, I'm not taking part from which you've just done one way or the other but I think, we as Freemasons need to make sure that our Fraternity stands high.

I said that I was in Alaska here I was looking for souvenirs. I walked into one of your fine gift shops. A little lady was there and met us and waited on us and I told her that I would like to purchase about 150 gifts for our ladies when we travel to Alaska next summer. And, after I made my purchase, I said to her how much deposit do you want? And, she said sir, my dad was a Mason and I trust the Masons all the way. This hasn't happened to me once Brethren but this has happened to me the last couple of months several times. People say your word is your bond. And, I think that stands great for our Fraternity.

I like to think our fraternity, Brethren, right now is like the great airplanes that we've flown to get here. Many of you have flown on some of these gigantic airplanes. And, you know how that relates to Freemasonry? Free masonry is like that giant airplane. All kinds of power, but Brethren just think that when that airplane is in the station or in at the loading dock, it can't get itself away from dock. It doesn't have the ability to get itself away from the dock. I find myself as Freemasons sometime with all the power we have and all the influence we have and all the desire we have for new members sometime we don't get ourselves away from the dock to let someone else know that they have to ask to be a Freemason. So, Brethren don't be like the airplane that's sitting at the dock, be like the one that's on the runway ready to take off. Don't allow yourself to have to have that pusher to push you out away from the loading dock.

I'd like to say that I have one other thing. Grand Master, yesterday you graciously handed Marvin Speicher, Tom Librandi, and myself a certificate that said that we're honorary

members of Grand Lodge of Alaska. Now when I thought about that then I should have something to say, I am an honorary member, this is what I would like to say, if I'm out of order Grand Master use your gavel. Now you didn't even give me a chance! I have a paper and I just had it faxed in as couple minutes ago because I couldn't find anybody to type in this area and I couldn't find a typewriter to use (Now I'm getting our of order, right?). But. it says The Grand Lodge of Pennsylvania presents to the Grand Lodge of Alaska a two-thousand dollar grant to be used as a Past Master's Performing Arts Scholarship Fund. The scholarship shall be used for high school seniors from Alaska or seniors who desire to go on to high education in the field of the performing arts. The scholarship will be one-half of the earned income from the grant after it reaches twenty-five hundred dollars, the other half to grow the scholarship fund. The fund shall be governed by The Most Worshipful Grand Lodge of Free and Accepted Masons of Alaska with the Past Grand Masters as judges for awarding the scholarships each year during the Grand Lodge session. Now I, Edward O. Weissner, Grand Master of the Right Worshipful Grand Lodge of the Free and Accepted Masons of Pennsylvania, a Masonic Jurisdiction thereunto belonging, authorize this grant on this 4th day of April to the Grand Lodge of Alaska, and I have signed it my name.

I'd like to say Brethren, that I have been giving scholarships in Pennsylvania to our high school seniors in the amount of five-thousand dollars for the scholarship for kids in their performing arts for music. We say in our second degree in Pennsylvania, we should be a lover of the arts and sciences and make every opportunity to prove ourselves therein and then we don't do anything about it. So, I would like to give this grant of two-thousand dollars to the Grand Lodge of Alaska and what it really says you will invest that and when it reaches twenty-five hundred dollars, which it should do in one year, that you will take half of that growth and give it as scholarship to a high school senior. The Past Grand Masters of this Grand Lodge can be that judge and the other half shall go back into the fund to enhance that fund and we hope it will grow and grow and grow so that this can be a viable scholarship that you can give to your high school students who we know are good kids. So, if I'm not out of order, Grand Master, I would like to present this to you at this time and the check's in the mail.

Brethren, I would like to say I was going to do this, Grand Master, but if the Past Grand Masters would see in their hearts, that they want to do this, if you want to name this scholarship after your current Grand Master that's fine with me. If you just want to keep it as a Performing Arts Scholarship title that's up to your Grand Lodge if you want a title, but we trust you will invest it.

Brethren, I would just like to say (GM Triggs: Can I sit him down,?) Sure you've got the gavel! But Brethren, I would just like to say to you that I listened to your reports today Brethren and I know that your Finance Committee's doing well. But just to bring you some ideas, and I'm willing to talk with any of your finance people, our Grand Lodge last year got 28.5% on our money and I would like to say during the last twelve years we have never gotten less than fifteen per cent in our investments. So, if the Grand Lodge of Alaska would like to share in how we've done this we would be more willing to offer anything to your Grand Lodge. I sit and listen and I know that our Grand Lodge at times

did not raise the money because we just weren't on the right road and we did a great job. I talked to our Grand Lodge finance people the other day and they told us that we're working on about nineteen per cent. Now, of course since the stock market last couple days, I don't know where we are. But, I just say to you Brethren that we have done that and have done it consistently for many years.

I know your incoming Grand Master said he is going to be working on it. He has talked about this before, but it's our privilege really. Everybody here has been so great to us Brother and we just feel that we are at home and in fact I've been thinking about taking membership in one of your Lodges up here but they tell me I'll get blackballed. Thank you.

RW Tony P. Wordlow, Deputy Grand Master of California

Most Worshipful Grand Master, Members of the Grand Lodge of Alaska if you want to hear an instance, I will tell you about one this afternoon. I got kicked out of the meeting. RW Gordon I. Kimball, Past Junior Grand Warden of Maine

Worshipful Grand Master, Distinguished Visitors, and the most Distinguished-the Brethren present, I bring you the greetings of the Grand Lodge of Maine, our Most Worshipful Grand Master Walter McDougall.

If you want to know what we're doing in Maine, I would like to invite you to Maine. We need the money, but our Grand Lodge is flourishing, it's moving. Just two weeks ago I had the opportunity to be with them, better than one-hundred of us went to the George Washington National Masonic Memorial in Alexandria, Virginia and worked the three degree on a Brother and if I was informed correctly, I believe it's the first time a visiting Grand Lodge ever worked in that Washington Alexandria Lodge hall at the Memorial.

Back in the '87, '88 era we started giving \$500 scholarships to each high school in the State and when it came to 1990 we were giving, with the help of the other Masonic groups \$500 scholarships to every high school in the state. I will correct myself, we started with two in each district. We have twenty-four districts in Maine. We gave two \$500 scholarships to each district and since about 1990 we have been giving \$500 scholarships to every high school in the State since then. We give up in the thousands of dollars every year to the DARE program which operates through our state school system. We furnish the money and they form the retreats whereby the teachers go and get their information on the DARE program to take back to their schools to instruct the children how to have their own minds and not succumb to the peer pressure where some student will say come on try this butt, try this alcohol, or something. We teach them the determination to think for themselves.

You've got things to do. I'm glad to be here. This isn't my first time in Anchorage (Ed: note, we're in Fairbanks) I've been here with the York Rite bodies. I've been to Alaska several times. I've known Lloyd for several, several years. Congratulations, this is another page in his book. His book is not finished; he has many pages and chapters to go yet. But, thanks for accepting me and I will be back.

W Howard Triggs, Grand Representative from Minnesota

His answer was very clear and simple, when I was Past Master back then they never gave you an apron, today they do. For an apron, you can get a Brother to do just about anything.

I know it wasn't possible, because our Grand Lodge is very close to yours and if any of you Brethren are heading toward Minnesota, passing through, please give me a call and I would be glad to offer housing to you. Most Worshipful Grand Master, Brethren of Alaska , and Masons all, again I bring you greetings from our Grand Master Benny L. Gresham in Illinois. We have some programs that we are very proud of as well. We have a drug and alcohol program which is similar to the DARE program whereby we take teachers from different schools and put them in a seminar where they are able to determine what to watch for with their children who are on drugs and alcohol. Throughout the State of Illinois we have had more than 1,500 teachers thus far in this program and the results are excellent.

We also have a Masonic academic bowl. It's similar to the GE College Bowl whereby we have the high schools are all sponsored by Masonic Lodges throughout the State of Illinois. We have, last count, this year we had 240 high schools involved with ten members in each team. When this competition comes along, the youngsters, many of them have no knowledge of Masonry and as they leave these buildings we present them with scholarships for their school and for them. Also we present them with a certificate with the signature of the Lodge Master, Secretary on it for each child and they have a medallion that goes around the neck with the Masonic emblem on it that is about 3 ½ inches in diameter. Thereby, they at least have the Masonic emblem in their houses and hopefully they will ask some questions.

It's been a great time this weekend or this week. It's really not a weekend, I'm from Illinois and weekends are Saturday and Sunday usually, but, I do thank you for your patience. Thank you for the great hospitality I've received and if you'd go to Illinois in our Grand Lodge you certainly will hear about Alaska because when I go back I tell them about how wonderful people are here and the great times that I've enjoyed over the past years. This is my third trip and I too want to be here again. Thank you Most Worshipful Grand Master.
