

### SITKAN JOE ASHBY RECEIVES HISTORICAL SOCIETY AWARD

Daily Sitka Sentinel, Sitka, Alaska, November 3, 1992

Joe Ashby, a longtime Sitka resident, received the Alaska Historical Society's Evangeline Atwood Award for Historical Excellence Friday night at the society's annual meeting in Anchorage,

Ashby, an active member of the Sitka Historical Society and a member of the state society's first board of directors 25 years ago, was honored for his "sustained contributions to historical activities in Alaska."

In nominating Ashby for the state award, Sitka Historical Society board members call him "an 'oral responder' to ever possible sort of question about Sitka and its people. He is acknowledged by many, including both the Sitka Convention and Visitors Bureau and the Sitka Historical Society, as being able to call to memory personal relationships and activities of early Sitka as well as contemporary Sitka...

"For his work with the Alaska

Historical Society, the Sitka Historical Sites Preservation Committee, the Sitka Historical Society and for being 'Mr. History' of Sitka, Joe Ashby is nominated for the Atwood Award."

Ashby, originally from North Dakota, came to Sitka after World War II following his discharge from the U.S. Navy. He worked for Sitka Cold Storage and Sitka Realty, was city assessor, a magistrate and, for 20 years, superintendent of Sitka National Cemetery.

He has been active in many community endeavors, including the Alaska Day Festival, and served as chairman of the St. Michael's Cathedral Restoration Committee.

He's a member of the Sitka Elks Lodge, is a Master Mason in the Sitka Masonic Lodge and is a member of the Scottish Rite and the Shrine. He also is a member of the Pioneers of Alaska, and just finished a term as state president.

He has served as a member and officer of the Sitka Historical Society from the time of its founding in 1957 until the present. He helped develop what is now called the Isabel Miller Museum, located in the Centennial Building. News of the Grand Lodge of Alaska

Several Brothers asked some questions that deserve answers. Some wanted to know - "Why now?" Now because several other Grand Lodges in the U.S. have granted varying degrees of recognition to Prince Hall Lodges in their respective states and some of our brethren wanted us to do the same. Several wanted to know if Prince Hall Grand Lodge of Alaska had asked for recognition? The answer to that is NO! However, I talked with several Prince Hall Grand Lodge officers last summer their feeling toward about recognition. Most of them stated that they would be in favor of recognition and visitation rights but would not be in favor of any type of merger. One brother

wanted to know if Prince Hall Masons have to profess a belief in God as we do? The answer to that is yes, their requirements and standards for membership are identical to ours. Some people have suggested that Prince Hall Masons are more critical and selective when balloting on new members than we are. This, however, is their personal opinion and is very subjective.

There were also four other surveys received but were invalidated because they could not be identified as members of this jurisdiction. Their results were identified as (1 Yes and 3 No's).

### Several Surveys included comments such as the following!

"I think we should let lie until they apply for recognition and ask for a petition. Maybe some day in the future they will."

"Masonry: Historically-Masonry has been segregated. I believe in honoring our fraternity past choice. I have friends who are Prince Hall Masons and respect them, but I don't wish to combine our Lodges."

"Yes I enjoyed your article very much. It was right to the point. Keep me advised...."

"Yes-Due to volatility of issue, I wonder if any passive survey such as this could be accurate.

"No-No need to"


"No-Especially since they have not requested recognition, or have they? If they haven't, why are you doing this?"






The Scottish Rite had a Great reunion in May with 8 new members. They are also dark during the summer months.


In closing, I would like for the Lodges to make good use of our Membership Renewal Kit. I have one available at this time. Just give me a call at 243-8350 to get it.

### A REPORT ON FREEMASONRY by, Home Mission Board, Southern Baptist Convention

The long awaited report of the Home Mission Board, Southern Baptist Convention (SBC), on the study of the compatibility of Freemasonry with Christianity and southern Baptist doctrine has finally emerged.

The report both praises and criticizes Freemasonry.

It commends the Masonic order "for its many charitable endeavors; "such as its hospitals." It also acknowledges many "outstanding Christians and Southern Baptists who have been and are Masons.

The report also recognizes that "many of the tenets and teachings of some Grand Lodges could be considered compatible with, and even supportive of Christian faith and practice, such as the strong emphasis on honesty, integrity, industry and character, and the insistence that every member believe in God."

The report lists several examples from Masonic publications, including one from the "Louisiana Masonic Monitor." It reads: "However they may differ in creed or theology, all good men are agreed that within the covers of the Holy Bible are found those principles of morality which lay the foundation upon which to build a righteous life... It is the one volume which has lived in the hearts of the people, molding and shaping their destinies, and it leads the way to Him who is the Light of the world."


In addition to such affirmations, however, the report notes that many Freemasonry tenets and teachings are not compatible with Christianity or Southern Baptist doctrine. It outlines eight areas:

1. The prevalent use of offensive concepts, titles and terms, such as Worshipful Master for a lodge leader, references to Masonic buildings as mosques, shrines or temples and the use of terms considered to be the secret name of God. "To many, these terms are not only offensive but sacrilegious, the report notes.

2. The use of offensive rituals "bloody oaths" considered by many to be pagan and incompatible with Christianity.

The report cites three examples, in which Freemasonry members swear allegiance to Masonic obligations, with transgressions punishable by such things as having one's throat cut or body severed. "Even though these oaths, obligations and rituals may or may not be taken seriously by the initiate, it is inappropriate for Christian to, 'sincerely promise and swear', with a hand on the Hold Bible, any such promises or oaths, or to participate in any such pagan rituals," the report says.

3. Recommended reading "of religions and philosophies, which are undeniably pagan and/or occultic."

4. "The reference to the Bible placed on the altar of the lodge as the 'furniture of the lodge', comparing it to the square and compass (symbols of Freemasonry) rather than giving it the supreme place in the lodge."

5. "The prevalent use of the term 'light', which some may understand as a reference to salvation rather than knowledge or truth."

6. "The implication that salvation may be attained by one's good works, implicit in the statement found in some Masonic writings that 'Masonry is continually reminded of the purity of life and conduct which is necessary to obtain admittance into the Celestial Lodge above where the Supreme Architect of the Universe preside.' Even though many Masons understand that the 'purity of life and conduct' can only be achieved through faith in Jesus Christ, other may be led to believe that they can earn salvation by living a pure life with good conduct."

7. "The heresy of universalism (the belief all people will eventually be saved), which permeates the writings of many Masonic authors, which is a doctrine inconsistent with New Testament teaching."


8. Refusal of most lodges to admit African-Americans as members.

The report concludes with its recommendation to leave Masonic membership as a matter of personal conscience and with an exhortation for Southern Baptists "to prayerfully and carefully evaluate Freemasonry in light of the Lordship of Christ, the teachings of the Scripture, and the findings of the report, as led by the Holy Spirit of God."



#### GIANT SQUARE AND COMPASS TO DECORATE MASONIC FLOAT

The most majestic and symbolic float to ever represent the Family of Freemasonry has been entered in the 1994 Tournament of Roses Parade.

Emblazoned with a 16-ft high square and compass, the colorful 55-ft long float will for the first time immediately convey the dynamic imagery of Freemasonry as it rolls down Colorado Blvd. New Year's Day in Pasadena.

Grand Master Stephen R. Doan and float committee chairman Stanley Channon both predict the float will make a strong impact on an international audience of millions of viewers.

"There will be no question who the float represents in this, the most watched television event of the year," said Channon, himself a Past Grand Master.

In addition to the square and compass, other symbols and tools of Masonry will decorate the float.

An open book on the front of the flower-adorned entry showing the enumeration of the seven cardial virtues honors the 75th anniversary of DeMolay. A candle symbolizes the illumination of the darkness, and various books devoted to geometry and architecture convey other aspects of Masonry.

And in the center of the float is a large globe depicting the universality and scope of the various orders of the Family of Freemasonry.

Constructed again by C.E. Bent & Son, Inc., the float will make wide use of a variety of flowers, according to Bill Lofthouse, president of the firm.

The garden areas around the base of the entry will be made up of roses, orchids, gladiolus, iris, gerberas and carnations. The symbols and tools are to be covered with bark, seed, strawflowers and eucalyptus.



"In light of the fact that many and teaching of tenets Treemasonry are not compatible with Christianity and Southern Baptist doctrine, while others are compatible with Christianity and Southern Baptist doctrine, we therefore recommend that with consistent our denomination's deep convictions regarding the priesthood of the believer and autonomy of the local church, membership in a Masonic Order be a matter of personal conscience. Therefore, we exhort Southern Baptists to prayerfully and carefully evaluate Treemasonry in the light of the Lordship of Christ, the teachings of the Scripture and the finding of this report, as led by the Holy Spirit of God." --HMB Report
