Greeting Brethren,

few war stories in between. Thank you to all the brethren in the Kenai Lodges, the Fairbanks Lodges, Valdez, Cordova, and Kodiak Lodges for your warm welcome and hospitality.

During the visits to the combined lodges, Anchorage, Matanuska Valley, Fairbanks, and Kenai, I expected to see the lodge room full of brethren from all the lodges represented. We may need to reevaluate the Grand Master's Visitation Schedule and allow you to give us some feedback about how we can make the visitations better. Remember brethren, the Grand Lodge Officers truly work for you and we want to do all we can to make the Official Visit meaningful to all Lodges, not just the "Host Lodge".

The majority of the brethren's response was to reinstitute the Warden's Charge or The Lodge Officer Leadership Training Program. The training will be the day before the Grand Lodge Communication at the Anchorage Masonic Center, 1431 Eagle Street, on January 31, 2012 from 1:00 to 5:00 PM. If you are staying at the Sheraton Hotel, we will provide transportation for the training from and back to the hotel.

The Grand Lodge Communication Registration and Forms should be on each Lodge Secretary's Desk by now. Please get a copy of the forms and register early to attend the Grand Lodge of Alaska Annual Communication. The dates for the Communication are February 1-3, 2012. I hope to see you there.

All of Southeast Alaska is visited by cruise ships, during the summer months, and quite often lodges in this region are alerted to the arrival of Masons aboard the ships. When possible, the brethren from Ketchikan lodge turn out with open arms to welcome these Mason's. MW Brook Cunningham, Grand Master of Arizona, who visited Mt. 
separate occasions) and asked to explain Masonry to a grandfather's grandson and to a father's son.


"Do all the good you can, By all the means you can, In all the ways you can, In all the places you can, At all the times you can, To all the people you can, As long as ever you can."
