#### - From Most Worshipful Brother F. "Drew" Lane


My Brethren:

Words cannot express my gratitude for the honor you have bestowed on—and the confidence you have reposed in — me by electing me Grand Master of Masons in our great State.

To make this honor even more poignant, the Worshipful Master and brethren of Solomon's Lodge No. 1 were kind enough to provide the Oglethorpe Bible, given to the oldest continuingly existing lodge in our State and in North America by the founder of the Colony of Georgia in 1734, on which Holy Bible I took the obligation as Grand Master, and for that kindness I am extremely grateful. While the office of Grand Master is a great honor, it is also an immense responsibility to be entrusted with the care and wellbeing of our great fraternity in this State.

Please know that I take that responsibility seriously, and I accept it with the utmost thanks and humility. Freemasonry does a great deal of wonderful work in the world and in Georgia, including, but certainly not limited to, GAChIP, which has provided tens of thousands of Georgia parents with the best possible identification for their kids; and, of course, the Masonic Home of Georgia, which has stood for 110 years as the jewel of Georgia Masonry and has provided a morallygrounded raising for many, many children. To these and other programs, Georgia Masons should remain committed. For just one example, our Masonic Home has begun a campaign to build cottages on our campus to provide our children with an even better family-style environment, while preserving the building we have used to raise the children in our charge for more than a century.

In addition to the laudable and charitable work we do in Georgia and



in our communities, however, we must remember and focus on the primary aim of the Masonic Institution, as communicated to every Mason: "to make its members wiser, better, and consequently happier...by means of a series of moral instruction taught, according to ancient usage by types, symbols, allegorical figures and lectures." The noted actor Edward Albert said, "[i]n times of life crisis, whether wildfires or smoldering stress, the first thing I do is to go back to basics..." While one would not want to interpret any of our current challenges as cause for panic – every age has its opportunities for improvement and growth – a renewed attention to the fundamentals is always appropriate. Just as no centerfielder in baseball ever robbed a batter of a home run by a spectacular catch over the fence without hard work on the basics of catching a ball, we as Masons could not better our communities without bettering ourselves and each other, and we do that by learning the basics of our Craft through the principles of Masonry as expressed in our ritual and lectures and by putting those noble teachings into practice in our daily lives. Indeed, any problem we may have, in our lodges or in the world, can be solved by a

sincere application of the principles of Freemasonry.

In that vein, I hope to elaborate on our theme for the year, "Living the Learning," in these notes and in our meetings and conventions over the coming months. To be certain, we will have to make the great catch, whether it be by collecting blood, building a wheelchair ramp, creating a better environment for our youth, or any number of other laudable undertakings. We Masons, however, will not do a creditable and sincere job at any of those works without building ourselves through learning and living true charity, peace, harmony, and morality. With these things in mind, I am confident that together, we can do great things for

ourselves, our families and our communities.

So far, it has been my pleasure to travel more than 3,300 miles to 19 meetings and Masonic functions on your behalf, and I have been most gratified and humbled by the hospitality and kindness the Freemasons of this State have shown me. Thank you for the opportunity to meet and fellowship with you this year, and I look forward to seeing you somewhere soon.

May God bless each one of you and our noble Craft.

#### F. Andrew "Drew" Lane, Jr. Elected Grand Master

At the 229th Annual Communication of the Most Worshipful Grand Lodge of Georgia, F. Andrew Lane, Jr. was elected and installed as Grand Master. Born August 13, 1962, in Atlanta, Fulton County, Georgia, Bro. Lane and his wife Margie live in Dallas, Paulding County, where he practices law.

Our Brother was educated in the Atlanta Public Schools and graduated from Northside High School in 1980 with honors. He attended Oxford College of Emory University, where he earned his Associate of Arts degree in 1982. He continued his higher education at Emory University in Atlanta, where he graduated with a double B.A. degree in History and Political Science in 1984. Drew worked his way through college at the Oxford College Library and later at Crawford W. Long Memorial Hospital of Emory University. After graduation, Lane edited a small newspaper and then was news director at a local radio station in Tallapoosa before entering Walter F. George School of Law at Mercer University in Macon, where he graduated in 1988 with a J.D. degree. While at Mercer, Bro. Lane served on the Moot Court Board for two years, the last as Treasurer.

Upon graduation, Bro. Lane began practicing law with Jeffrey B. Talley and Associates, P.C. in Dallas, Georgia. He later hung out his own shingle as F. Andrew Lane, Jr., Attorney at Law, in downtown Dallas, where he practiced until being appointed an Assistant District Attorney for the Tallapoosa Judicial Circuit in 1995. Lane was a prosecutor for ten years before being appointed District Attorney for the Paulding Judicial Circuit in 2005 by Governor Sonny Perdue. He served in that capacity through the end of his elected term in 2010 and then worked as Director of Fraud Investigations for the State Department of Insurance before returning to private law practice.

Professionally, in addition to being a member of the State Bar of Georgia, Bro. Lane is admitted to practice in the Supreme Court and Court of Appeals of Georgia, as well

as the United States District Court for the Northern District of Georgia. He served as President of the Paulding County Bar Association in 1990.

Bro. Lane is a member of First United Methodist Church in Dallas, where he has sung in the Chancel Choir. He was a member of the Church's Board of Trustees from 1993 through 1995 and served as Chairman in 1995.

In civic life, Lane was a member of the Paulding County Civitan Club for approximately 20 years and served as President of the local club in 1990-91. He quickly became active on a district level, and served as Governor of Civitan Georgia District North, then comprised of 43 local clubs, in 1993-94. After his year as District Governor, our Brother worked with youth as District Co-Chair of Junior Civitan Georgia District North for five years.

Lane was active in public service since running for and being elected to the Dallas City Council in 1993. He served as City Councilmember from Ward 3 for eleven years, during most of which time he was the City of Dallas representative to the Paulding County Parks and Recreation Commission, of which he was Chairman in 2005. In that year, he was appointed by the Governor to fill an unexpired term as District Attorney for the Paulding Judicial Circuit, where he served the people of Paulding County and Georgia for almost six years.

Bro. Lane has been an active Freemason for 30 years, having been initiated, passed and raised in Tallapoosa Lodge No. 126 in 1985. He progressed through the chairs in Tallapoosa while in law school in Macon and served as Worshipful Master in 1988, the year he graduated. He transferred his membership to Dallas Lodge No. 182, the lodge closest to his home, in 1990. Progressing through the line in Dallas, he served as Worshipful Master in 1995 and again in 2003. Draketown Lodge No. 252 admitted him

to plural membership in 2001, and he was Worshipful Master there in 2002. He is a charter member of Paulding County Daylight Lodge No. 759, one of the newest lodges in the state.

A Mason who enjoys the Uniform Work, Lane served for several years as Director of Work in Dallas Lodge and at Draketown. He holds blue, white and orange cards and regularly attends schools of instruction in the Seventh Masonic District. Lane continues to be active in degree conferrals with Dallas Lodge, the Dallas Fellowcraft Club and the Grand Lodge Officers and has expressed his hope to participate further in Blue Lodge degree work over the coming year.

Most Worshipful Brother Thomas Reese appointed Lane as District Deputy to the Grand Master for Sub-District 7-E mid-year in 2000, and since then, Lane has served eight more Grand Masters in that capacity. In 2001, Most Worshipful Brother C. E. (Buster) Horne appointed Bro. Lane Trial Commission Chairman for the Seventh District, which position Lane held until 2005. Lane served as Worshipful Master of the Seventh District Masonic Convention in 2013 and also Past Master of the Paulding County Masonic Convention.

Bro. Drew received his Scottish Rite degrees in the Valley of Macon in 1986. He transferred his membership in 2000 to the Valley of Atlanta, where he is Past Preceptor of the Council of Kadosh. He received the rank and decoration of Knight Commander of the Court of Honor in 2003. Lane has been active in Scottish Rite degree conferrals for years and participated in the most recent Reunion in Atlanta.

In the York Rite, Lane took the Royal Arch and Council degrees and Commandery orders in 2001. He is a member and Past High Priest of Dallas Chapter No. 142, R.A.M. and Douglasville Chapter No. 50, R.A.M.; a member and Past Illustrious Master of Douglasville Council No. 37, R. & S.M. and Western Council No. 29, R & S.M.; and a member and Past Commander of Douglasville Commandery No. 40, K.T. He has long been active on a district level, as well, having served as High Priest of the Seventh District Royal Arch Convention and as Illustrious Master of the Council of the Seventh District Council Convention. Bro. Lane was Division Liaison Officer for Division Four of the Grand Commandery of Georgia from 2007 to 2009. He is Past Excellent President of the Order of High Priesthood of Georgia and currently Thrice Illustrious Master of the Order of the Silver Trowel. Lane was elected to the progressive line of the Grand Council of Royal and Select Masters of Georgia in 2008 and served as Most Illustrious Grand Master in 2013.

Bro. Lane is a member of the Yaarab Shrine and a life member of the Paulding County Shrine Club. As for appendant bodies, he belongs to the Royal Order of Scotland, as well as Luther G. Palmer York Rite College No. 123. In addition, Lane is an officer and member of St. Ambrose Conclave, Red Cross of Constantine; Upper Room Tabernacle No. XLV, Holy Royal Arch Knight Templar Priests; Georgia Council No. 304, Allied Masonic Degrees; and Cherokee Rose Priory No. 56, Knights of the York Cross of Honour.



#### Brother Danny Fink's memories of September 11, 2001

His work day was winding down, as for many others who worked the night shift. He arrived home around 9:15 to take a quick shower and go to bed. As he lay down he turned the television on to listen to the Today Show. As he was lying there the program was interrupted with a report that a plane had struck the North Tower. As live footage, was being shown of this horrific event, Brother Fink, being a Paramedic in New York City, got up and put his uniform on to go back to work. As he was dressing he saw the second plane strike the South Tower.

Shortly afterwards, he heard the announcement that all Fire, Police and EMS were to report to their stations as soon as possible. When he arrived at his station at approximately 10:45 he couldn't believe what was happening as he saw the South Tower come down on the television. He went up to the roof of the station where he saw the North Tower fall.

He and his partner were dispatched to Ground Zero. Not being able to drive to the scene, they walked the last mile or so. As they arrived, everyone was in shock. Fink said, "It's hard to put into words how bad it was." Upon arrival they were sent to the South East Corner and assigned to Engine and Ladder 10. They turned the truck bays into a small ER and Trauma slots to attend to the injured.

The morning of the 12th Brother Fink began helping remove the rubble. He still remembers the only two parts of the planes that were recognizable were the emergency hatch and an engine.

He spent a total of 59 hours at Ground Zero before being ordered back to his station as he was reminded that they still had a city to take care of.

Since 911 Brother Fink has moved to Georgia. After retiring from the FDNY with health issues, many related to







#### Alzheimer's: Knowing The Signs, Getting Help

Who should pay special attention to this story?

Women, baby boomers and those with type 1

diabetes, though Alzheimer's can strike anyone.

It's a story told too many times. A family sees changes in a loved one. Soon, the diagnosis confirms the worst fears: it's the onset of Alzheimer's disease or one of the other dementias. We Georgia Freemasons, more than 39,000 of us, working in some 420 lodges know very well the importance of signs and symbols as part and parcel of our great fraternity.

Who should pay special attention to this story? Women, baby boomers and those with type 1 diabetes, though Alzheimer's can strike anyone.

We Freemasons can get involved next February 3rd at the Georgia state capitol. Read on for more on how we can help.

The media is brim full of continuing reports about Alzheimer's and its enormous costs. Alzheimer's is a large

part of the overall list of the dementia diseases and some 44 million people worldwide are living with these brain maladies. In the United States alone

around five million people have Alzheimer's; 15 million are their caregivers. Alzheimer's is the most expensive disease in the United States.

What happens when signs of Alzheimer's come calling and the eventual caregivers have no idea what to do next? There is help available and it's as close as the phone. That's where you find the First Team that can step up to the plate. All you have to do is ask.

The Alzheimer's Association is that First Team, the world's leading voluntary health organization in Alzheimer's care, support and research, something you'll learn from the mountain of information available from the association. There is an important fact about the organization: almost all of its' services are free. One might ask if something free is worth anything. If that's the question, the answer should astound the questioner after they learn

One of the first steps after hearing the diagnosis is to call the Alzheimer's Association helpline, open 24/7, and it's free. Professionals answer the phone. They can refer families and caregivers to local programs and services as well as help in decision-making about Alzheimer's and memory loss. With that call you'll learn about the on-going Alzheimer's research, medication and other treatment options. Wandering and safety concerns are reasons why enrollment in the MedicAlert®+ Safe Return® program is important for caregivers and people with dementia. The phone number follows at the conclusion of this report. The

help-line is also available for inquiries in 140 languages. The Association is well prepared to communicate with anyone needing direction and advice.

Members and families of Nelms Lodge No. 323 in Smyrna were presented a program by the Georgia Chapter of the Alzheimer's Association whose message was one of hope, courage and advice. The Georgia Chapter's Speakers Bureau is available to present programs about diagnosis, research, care and treatment. The programs with informative multimedia presentations are there for lodges and other organizations. Again, all you have to do is ask. When families learn how the Association can help in their time of need,the obvious relief in the room is palpable. Being a volunteer goes to the very heart of the Association's mission, to help in every way possible, answering questions

at all hours, again, there's that free help-line.

The Alzheimer's Association's 2015 International Conference in Washington DC

reported that early brain scans, memory evaluation and other tests may hold the keys to understanding a person's likelihood of developing Alzheimer's, even among those who don't yet have memory and cognitive problems associated with the disease. Certain biological changes take place over time that may signal the future onset of Alzheimer's. Understanding which changes are most predictive may help in selecting candidates for clinical trials and also help in measuring an individual's response to some

of the treatment or prevention strategies.

Reports from the conference included data on advanced trials and on three drugs targeting the abnormal beta-amyloid protein that forms plaques in the brain, one of the hallmarks of Alzheimer's. Also described were three drug trials that target other pathways and symptoms in the disease, including psychiatric disorders such as agitation. At the 2015 conference, sobering projections say that 28 million American baby boomers will get Alzheimer's by the middle of this century. If this holds, the costs will be enormous and consume nearly 25 percent of Medicare spending. Another recent study suggests that a treatment which delays the onset of Alzheimer's by five years could save \$220 billion within the first few years of its introduction.

Type 1 diabetes is also a risk factor for developing Alzheimer's. In the report, almost a half-million participants over age 60 with Type 1 were 60 to 93 percent more likely to

get dementia when compared with those without Type 1.

Women are also at greater risk of acquiring cognitive decline and dementia, according to the 2015 Alzheimer's Disease Facts and Figures report. Two-thirds of those living with Alzheimer's are women. Women are also more likely to be caregivers of people with Alzheimer's. We've been told for years that exercise is important to our well-being. More research continues to show this is no myth. Moderate to vigorous exercise improves lifestyles for people with Alzheimer's, depending on their individual condition.

And for the caregivers, one of the statements made at the Georgia Chapter's office of the Alzheimer's Association and heard by your reporter while preparing this article was this: "No one should have to go through this alone." When the staff and volunteers of the Alzheimer's Association come into the picture they make the world of the caregiver and person with dementia a different place.

The Alzheimer's Association needs the help of all of us by our financial contributions and other assistance we can extend. There are seven regional offices in Georgia where much help is available and volunteers are welcomed. In fact, volunteers are integral to the mission of the association which is becoming more of a volunteer-driven organization.

It's also important to participate, if possible, in the Alzheimer's Awareness Day at the Georgia State Capitol, Wednesday, February 3, 2016, 8:30 a.m. - 2:00 p.m. More details and registration information is available on the Association's advocacy page: www.alz.org/georgia.

Finally, when a family needs counseling, free help is available 24/7. Call the helpline number at 1-800-272-3900. For families struggling with Alzheimer's or one of the other dementias, support is essential. Support of the Alzheimer's Association is vital.

and from their VA appointments at the Hospital and CBOC's.

Mental Health. Groups needed to take on sponsorship of quarterly activities enhancing interaction and social skills for our Veterans in OATC, MHICM, and PRRC. These programs are very helpful in patients with PTSD.

OEF/OIF. This program provides items of necessity to include: food certificates, gasoline cards, Marta Breeze cards and phone cards.

Oncology Clinic, "Look Good, Feel Good" program. This program is co-sponsored by the American Cancer Society (ACS) who works with other non profit organizations to give recent chemo patients cosmetic makeovers. We are looking for support with purchasing wigs and othe incidentals for this program.

Palliative Care. This program supports Veterans along with their family to make their last days of the Veterans life as special as possible.

Traumatic Brain Injury program. This program, with the IED's used now, is very much in need. Sponsorship of Veterans with traumatic brain injury (TBI) is needed. This includes education presentations, interaction and social skill activities for memory compensation, quick TBI contact reference items, word search and crossword puzzle books and relaxing instrumental music CD's for meditation. Also phone cards and again Coffee supplies.

And to include our youth groups. We have programs for our DeMolay and Rainbow girls to volunteer time also. And if your Lodge sponsors a Boy Scout or Girl Scout group also. Summer Student Program. Sponsors are needed for the annual Summer Student program at \$50 per student. This opportunity provides the student an opportunity to work in the VA environment, function in an administrative and professional environment, as well as assisting our Veterans patients and learning from their military experience. The Veterans always enjoy very much the youth that comes to help them. Especially if you have a Jr ROTC program or CAP Cadets in uniform.

Our VA's are always appreciative for all the gifts and donations received in support of our Veterans patients. As you can imagine, our patients wish list is always changing as projects are completed and new ones are established. Many of our projects need funding support on a regular on going basis. Please call or see your local MSA Rep or call the VAVS at your local VAMC if you have any questions. Checks should be made out to your local Faculity, ie Atlanat VAVS, Augusta VAVS. or Dublin VAVS, and may be delivered to VAVS in person by your Lodge, mailed or given to your local MSA Rep to deliver. Please be sure to let us know which fund or purpose your donation is to be used for by noting it on the memo line on your check.

#### **Veterans Corner**

Rick Conn, MSA Hospital Visitation State Coordinator

Brothers, some of you have asked me what you can do for the VA Hospital. There are several programs that you can get involved with if you want to volunteer your time. And of course you can schedule your time to visit with the Veterans that are in nursing homes. They always enjoy your visits, especially around the holidays. You can contact your MSA Representatives in your closest VA and they can help you get started. You will need to attend an orientation class at the VA and get your name on the list with VAVS. (Veterans Administration Voluntary Services) Tell them to list your organization as Masonic Service Association so the Masonic Rep in the Hospital can collect your time and turn it in to get credit for hours served by the Masonic Fraternity. In Augusta you can contact Brother Chuck Riggin, in Dublin Brother Doc Bowman, and Atlanta Bro Victor McKelvey or myself. The time you serve is rewarding and appreciated very much by the veterans that we serve.

If you want to help but do not have time to volunteer, then there are several ways you can do this. This time of year you can "Adopt a Veteran" for the holidays. You can provide a special Christmas for a Veteran and their family who are in need. These families are identified through the VA Social Workers within your Va faculity.

Canteen books, Currency used by patients in need: distributed by social workers, coffee supplies: coffee and coffee supplies are needed to support the medical center, CLC and CBOC's for Veteran patients. Comfort Kits: Patients who need hygiene products are given a kit containing items such as toothpaste and toothbrush, deodorant, comb, shampoo, body wash, and powder. Donations can always be dropped off at the VA VAVS office between the hours of 8:00 am and 2:00 pm Monday thru Friday. Obtain a form to list what you donate and where it comes from and the organization (MSA) and you, your Lodge, etc will receive a letter thanking you for your donation. If an individual, this letter can be used

for tax purposes also come tax time for donation exemptions.

In our CBOC's (Community Based Outpatient Clinic) Groups are needed to sponsor individual CBOC's special emphasis programs ie; patient education seminars and ceremonies. Health Fairs and Job Fairs, and of course Coffee Supplies are always needed for our out patient veterans while waiting for their appointments.

In our CLCs (Community Living Center) items are always needed. We have several community living centers located on the floor of the hospital where veterans can go to just relax. Visit with other patients, or a place to bring family in a home living room setting. The hospital in Atlanta we have two, one on the 2nd floor and one on the 3rd floor. We have a fish tank in both of these for our veterans to enjoy. Monthly funding for maintenance and fish food are needed. This usually cost around \$250 per month that is not paid by the VA, but by individual sponsors. Check with your local VA facility and see tf they have special needs also.

We now have a new CBOC located at Fort McPherson. We have a male and female homeless Veterans Domiciliary there. They are always in need of items donated that the VA does not furnish. Backpacks, hygiene products, undergarments, sweat suits, therapeutic rehabilitation activities and Marta Breeze tickets for our veterans. Again contact your local VAVS or your Masonic Service Association Representative to get these items to the program if you do not have the time to take them yourself. The MSA Rep will either return to you or mail to you the donation form for your thank you and other uses you may need it for. Male veterans, Tshirts, briefs/boxers, socks, slippers and pajama bottoms. Female veterans accessories are also needed, ie: nail polish, hairbrushes, mirrors, panties (M/L), sports bras, socks, slippers and female personal hygiene items.

Food Certificates. Food certificates are provided to our Veterans during the holiday seasons. Each certificate cost \$50 feeding a family of six. These certificates are distributed to Veterans and their family members identified through the VA Social Workers.

HUD-VASH. Homeless Veterans that have been placed into housing are in need of Welcome Kits. The kits may include household goods, cleaning supplies, kitchens items and bathroom items.

Marta Breeze tickets. Provided to Veterans without any means of transportation identified through the VA Social Workers and DAV Transportation services, to get them to

Woodbine Lodge No. 326 celebrated its 110th anniversary by asking the Grand Lodge to lay a cornerstone on their lodge hall. The lodge hall was dedicated on October 31, 1895. It is the only lodge hall Woodbine No. 326 has occupied. The lodge met in a barn before the lodge hall was completed. It was the only two-story building in Woodbine to survive a Category 4 hurricane in 1898. During its early years, the lodge met in the daytime so the Brethren could see to get home after lodge. For a time, the lodge rented the downstairs for a grocery. A man was killed in the grocery and the lodge Brothers believe his ghost still roams the lodge hall. It is known the murdered man smoked a cigar. Brothers today say they can smell cigar smoke but none of the Brothers smoke a cigar. The Brethren have done a good job remodeling the lodge hall and it is attractive inside and out today. They have every reason to be proud of their lodge.
